

Admission Requirements Raised

Requirements for admission to the College of Law, effective September 1, 1952, will be increased from two to three years of acceptable college work in compliance with the amendment to the bar admission rules promulgated by the Supreme Court of Tennessee on March 9, 1951, and with the recently increased standards of both the American Bar Association and the Association of American Law Schools.

The College of Law was represented at the annual meeting of the Association of American Law Schools, held in December at Denver, Colo., by Professor Miller. Professor Miller is chairman of the association Committee on Legal Aid Clinics and presided at the Round Table Meeting on Legal Clinics held at the meeting.

Comments By Law Faculty And State Bench And Bar Featured At Law Institute

The Twelfth Annual Law Institute, sponsored by the University of Tennessee College of Law and its alumni, was held Friday, November 30, 1951 in the College of Law Building. Members of the faculty spoke on the following topics: Dean Wicker — Jury Panels in the United States District Court for the Eastern District of Tennessee; Professor Baugh — Selecting a Jury in the Circuit and Criminal Courts of Tennessee; Professor Overton — Broadening the Basis of In Personam Jurisdiction in Tennessee; Professor Miller — Current Problems in the Administration of Criminal Justice in Tennessee. Those addresses appear in the February issue of the Tennessee Law Review.

In addition to the principal speakers, each address was followed by a commentary by two outstanding members of the Tennessee Judiciary or Bar.
