**CODE OF ACADEMIC CONDUCT**

All members of the College of Law professional community must be kept informed of the standards of ethical conduct in the College. The Dean's office will report within the College the essential facts and the penalty imposed in every case in which discipline is imposed under the Code of Academic Conduct. The report will not disclose the identity of the student or students involved. The report will describe the conduct engaged in, will specify the respects in which that conduct violated the Code of Academic Conduct as interpreted and enforced within the College, and will specify the penalty imposed. Report of this information will be withheld only in the exceptional case in which accurate disclosure of the conduct would, ipso facto, disclose the identity of the student or students involved.

This is brought to the attention of all members of the College now, while no matter of academic conduct is pending, so that all may know that disclosure in the form specified will be the final step in every future instance in which discipline is imposed.
