LAW STUDENTS AND FACULTY HONORED DURING "LAW WEEK"

The University of Tennessee College of Law celebrated "Law Week" by recognizing outstanding achievements by students and faculty during the year.

The first place prize in the Advocates' Prize Moot Court Competition was presented to the team of Elizabeth Einstman and Virginia Gandy. They triumphed over the team of Tim Simonds and Andrew Walsh. Ms. Gandy was named Best Oralist. The Best Brief award went to the team of Ms. Einstman and Ms. Gandy.

The team of Stephen Duggins and Thomas Dean won the Ray H. Jenkins Trial Competition. Second place went to Robert Kosky and Edward Lanquist.

Special citations for outstanding contributions to the College were received by John Tishler for his work as the Editor in Chief of the Tennessee Law Review, Julie Taylor for her role as chairperson of the Moot Court Board, and Chloe Reid for her leadership as President of the Student Bar Association.

Students receiving academic awards included Andrew Tillman, Kate Stephenson and Julie Watson. Mr. Tillman also received a special award from the Knoxville Bar Auxiliary to the Tennessee Bar Association for academic achievement during the first year of studies. Ms. Stephenson also was presented the Herbert L. Davis Trust

Fund Award and the Callaghan and Company Book Award for academic achievement for a second-year student. Ms. Watson, a June 1987 graduate now associated with the Chattanooga firm of Caldwell, Heggie & Helton, also received a prize from the Michie Company, which is given to the graduate with the highest grade point average. Edwin Daniel, a June 1987 graduate, received the United States Law Week Award, which is given to the student who made the most academic progress during the third year of studies.

Richard Saas received first prize in the Nathan Burkan Memorial Competition, which is a writing competition concentrating on patents and trademarks. Second place went to Patricia Bryant, a December 1987 graduate.

The Charles H. Miller Award for proficiency in legal clinic was presented to Richard Moore. Perry Piper is the first recipient of the James Powers III Clinical Achievement Award. James Powers, a third-year law student, was killed in a car accident earlier this year.

Elizabeth Farr received the McClung Metal which is named for Calvin M. McClung and is awarded to a student who exhibits superior skills in inter-school trial or appellate moot court competition. Ms. Farr was a member of the Philip C. Jessup International Law Moot Court Team and was named third-place Best Oralist in the Southeastern Regionals in Miami.

Up till now there have been some great advantages for law students in being on a different registration schedule than the rest of the University. Schedules have been picked up in the Law College, fees have been paid, financial aid collected, and ID's validated in the Student Services Building. All of this has been done without the crowds that are normally associated with undergraduate and graduate registration.

THE WAY WE WILL BE

Because we will now be registering at the same time as the rest of the University, it will no longer be possible to manage schedule distribution, fees, financial aid, etc. in a separate manner. Since all of the activities that the University handles will take place in Stokely Athletic Center on August 22 - 23, we will also move schedule distribution for upperclass students to Stokely. We will have a separate law table or tables that should be easy to locate. But we have been advised that students should anticipate lines to clear delinquencies, pay fees, etc. We have also been advised that the early hours of the day tend to be the least crowded and lunch times, the worst.. So to avoid the congestion, make sure your delinquencies are cleared this spring and plan to arrive early. See Dean Hoover if you have questions.
