

## LAW REVIEW CANDIDACY PROGRAM

Sixty-five second-year law students have sent in letters of intent to take part in the Tennessee Law Review candidacy program that will begin August 10 at 9:00 a.m. in Room 118 of the College of Law. Former TLR editor-in-chief Judy Cornett will talk to the students about writing a casenote at the meeting.

During the summer, the candidates completed a "Blue Book Exam," which they will turn in on August 10 as a prerequisite to going on in the process. Candidates will learn what is expected of them over the two-week initial try-out process. During the first week, the students will write a closed-universe casenote. The second week's work will be on a research test. Students who pass the two-week process will then be invited to write a casenote for publication in the TLR. A final decision on their candidacy will be made in early October.
