

Legal Clinic celebrates 50th anniversary, hosts colloquium on clinical education

The University of Tennessee Legal Clinic celebrated its 50th anniversary Oct. 17 and 18, 1997, with a dinner and a colloquium on 50 years of clinical education.

Stephen B. Bright, executive director of the Southern Center for Human Rights in Atlanta, was the keynote speaker at a dinner Friday evening, Oct. 17, at the Knoxville Hyatt Regency Hotel.

The colloquium, entitled "Fifty Years of Clinical Education for the Profession," was held of Saturday, Oct. 18, in the law school building.

Clinton Lyons, executive director of the National Legal Aid and Defender Association, was the Saturday luncheon speaker. Colloquium topics included "Lessons from the Past: The History of Clinical Education," "Teaching Professionalism: The Role of Clinical Education," "Clinical Pedagogy, Legal Education, and the Profession," and "Lawyering Theory: Legal Education and the Profession."

The late Charles H. Miller founded the UT Legal Clinic in 1947 and served as its director until 1975. The UT Legal Clinic was the second such clinic to be founded in this country and today is the nation's longest continually operating legal clinic. The clinic in the new law school building is named for Prof. Miller, who retired in 1976 and died in 1996.

The UT Legal Clinic is a functioning law firm -- a teaching law office. Under a special rule of the Tennessee Supreme Court, third-year law students represent real clients in civil and criminal cases under faculty supervision.

Prof. Emeritus Durward Jones to be honored with professorship

The UT College of Law, in cooperation with alumni, has established a series of CLE seminars on tax issues to raise funds for a tax professorship in honor of Professor Emeritus Durward S. Jones. Prof. Jones retired in 1992 after 27 years as a member of the faculty.

The first seminar, "Probate and Estate Practice Under the New Tennessee Probate Code," was held in October 1997. Future topics will include Planning and Drafting, Estates and Trusts, and tax issues with regard to Qualified Retirement Plans. Future seminars will be held in Chattanooga, Nashville and Memphis with faculty taken from practitioners in those cities. Prof. Jones received a law degree from the University of North Carolina in 1954 and came to UT in 1965 after seven years in private practice and serving as Guilford County Attorney in Greensboro, N.C. He taught taxation and business-related courses during his tenure at UT. In 1992, Prof. Jones received the Student Bar Association's Outstanding Faculty Member Award. The Summer 1993 issue of the *Tennessee Law Review* was dedicated to Prof. Jones.

New law student group gets off to a strong start

The College of Law Speaker Series has enjoyed a strong showing in its inaugural year. The Speaker Series is a new student program at the College of Law designed to host prominent speakers who will address legal issues of importance to a broad spectrum of Tennesseans.

The next big event for the Series will be an interdisciplinary symposium entitled "Revitalizing Cities and Building Community" on April 4. The event will bring professionals from a variety of fields together to address the issues confronted by Tennessee's cities and large towns facing increasing urbanization.

"The format, along with the selection of co-sponsors, has been driven by a desire to bring together a variety of backgrounds and perspectives to address these challenges," said Will Ed Settle '98, Speaker Series Vice Chair for Speakers.


Continuing education seminars will be conducted by the Tennessee Bankers Association, the Tennessee Bar Association, the University of Tennessee College of Architecture and Planning, and the University of Tennessee Center for Entrepreneurial Law. In addition, two discussion forums will be held in which a panel of speakers will address a particular issue, take questions, and lead discussion.

One discussion forum, entitled "Economic Development in Tennessee's Cites," will include representatives from the Community Microloan Program, Leadership Chattanooga, and Leadership Memphis. The other forum, entitled "Urban Challenges and Grassroots Orgnanizations," will include members of the Center for Neighborhood Development, Community Partnership Center, Habitat for Humanity, Individual Development Accounts Program, and the Tennessee Municipal League.

The symposium will begin at 8:30 a.m. with a continental breakfast followed by a variety of continuing education seminars and special topic sessions. After lunch, the event will culminate with a keynote address followed by a reception. The event will conclude around 3 p.m.

1997 Hooding Ceremony

Marian Wright Edelman, founder and president of the Children's Defense Fund, spoke at the May 15, 1997 hooding ceremony for the Class of 1997. Two excerpts from her address follow:

"We are living at an incredible moral moment in history. Few human beings are blessed to participate or experience the beginning of a new century and millennium. How will we say thanks for the life, for the earth, for the nation, and for the children God has entrusted to our care? What legacies, principles, values, and deeds will we stand for and send to the future through our children, to their children, and to a spiritually confused, balkanized, and violent world desperately hungering for moral leadership?

"How will progress be measured over the next thousand years if we survive them? By the kill power and number of weapons of destruction we produce and traffic at home and abroad, or by our willingness to shrink, indeed destroy, the prison and violence constructed in the name of peace and security? By how many material things we can manufacture, advertise, sell, and consume, or by our rediscovery of more lasting, nonmaterial measures of success, a new Dow-Jones for the purpose and quality of life in our families, neighborhoods, and national community? By how rapidly technology and corporate mergermania can render human beings and human work obsolete, or by a better balance between corporate profits and corporate caring for children, families, and communities? By how much a few at the top can get at the expense of the many at the bottom and in the middle, or by our struggle for a concept of enough for all Americans? By the glitz, style, and banality of too much of our culture, or by the substance of our struggle to rekindle an ethic of caring, community, and justice in a world driven by money, technology, and weaponry?

"The answers lie in the values we stand for and decisions and actions we take today. What an opportunity for good or evil we Americans personally and collectively hold in our hands as parents, citizens, community leaders, and as titular world-leader in the post-Cold War and post-industrial era on the cusp of the third millennium. Czech Republic President Vaclav Havel said recently that 'there are good reasons for suggesting that the modern age has ended. Many things indicate that we are going through a transitional period when it seems that something is on the way out and something else is painfully being born. It is as if something were crumbling, decaying, and exhausting itself while something else still indistinct were arising from the rubble.'

"A thousand years ago the United States was not even a dream. Copernicus and Galileo had not told us that the earth was round or revolved around the sun. Gutenberg's Bible was not printed, Wycliffe had not translated it into English, and Martin Luther had not tacked his theses on the church door. The Magna Charta did not exist, Chaucer's and Shakespeare's tales had not been spun, and Bach's, Beethoven's, and Mozart's miraculous music had not been created to inspire, soothe, and heal our spirits. European serfs struggled in bondage while African empires flourished in independence. Native Americans peopled our land free of slavery's blight, and Hitler's holocaust had yet to show the depths human evil can reach when good women and men remain silent or indifferent.

"A thousand years from now will civilization remain and humankind survive? Will America's dream be alive, be remembered, and be worth remembering? Will the United States be a blip or a beacon in history? Can our founding principle 'that all men are created equal' and 'are endowed by their Creator with certain inalienable rights' withstand and test of time, the tempests of politics, and become deed and not just creed for every child? Is America's dream big enough for every fifth child who is poor, every sixth child who is Black, every seventh child who is Latino, and every eighth child who is mentally or physically challenged?

"Can our children, each of whom 'comes with the message that God is not yet discouraged of man' says Indian philosopher Rabindranath Tagore, become the healing agents of our nation and world transformation and future spiritual and economic salvation?"

"On Jan. 20, 1997, an extraordinarily important symbolic convergence occurred as we celebrated Dr. Martin Luther King Jr.'s birthday and inaugurated the last President of the twentieth century. The key question is whether we are going to just celebrate or truly follow Dr. King.

"Many citizens say, 'I am not Dr. King and can do nothing to stop child neglect and ill health.' But we all have some of Dr. King inside us, just as we are God's hands and heart and feet and voice in the world. 'When evil men plot, good men must plan. When evil men burn and bomb, good men must build and bind. When evil men shout ugly words of hatred, good men must commit themselves to the glories of love. Where evil men seek to perpetuate an unjust status quo, good men must seek to bring into being a real order of justice,' Dr. King counseled.

"Some stand mute when children and the poor are treated unjustly because they are afraid of controversy or failure. Dr. King too was often afraid of police dogs, or violence among his followers and foes alike, of disunity in the movement, and of failure in the face of seemingly intractable obstacles. But as a college student I heard him say to take the first step in faith even when the whole stairway is not revealed and to leave the results to God. He also said, 'If you can't run, walk. If you can't walk, crawl, but keep moving.' The important thing is to keep moving!"

Faculty News

Dwight Aarons participated in a panel discussion April 10 on the death penalty at Carson-Newman College. Various views on capital punishment were advanced.

Two of **Kelly Browne's** articles on vendor- and media-neutral citation were cited several times in a *Stetson Law Review* article. Prof. Browne directed a half-day workshop, "Teaching Legal Research in the Digital Age," at the American Association of Law Libraries Annual Meeting in Baltimore, Md., July 19. Also, she was named the American Association of Law Libraries (AALL) Government Relations Committee (GRC) Liason to AALL's Citation Format Committee and was appointed to the Tennessee Library Association's Legislation Committee. Prof. Browne was appointed Chair of the 1997-98 Research Instruction and Patron Services (RIPS) AALL Special Interest Section (SIS) Program Committee.

Kate Bunker gave a presentation entitled "Unemployment Insurance Law and the Americans with Disabilities Act" at the annual training meeting for the Appeals Hearing Officers of the Tennessee Department of Employment Security on May 14. The program, held in Gatlinburg, was "Current Legal Issues in Unemployment Insurance Appeals Hearings."

Judy Cornett spoke to UT English Professor Bethany Dumas's Language and the Law class April 4. Her topic was "Law and Literature." Prof. Cornett received a Ph.D. in English from the University of Virginia on May 19, 1997. Her dissertation was entitled, "The Construction of Female Subjectivity: Common Issues in Eighteenth-Century English Law and the Novel." Prof. Cornett is serving as a member of the Steering Committee for Law Women's 25th Anniversary Celebration, to be held in March 1998. Prof. Cornett's article, "Hoodwink'd by Custom: The Exclusion of Women from Juries in Eighteenth-Century English Law and Literature," was accepted for publication in the Fall 1997 issue of the *William and Mary Journal of Women and the Law.* Prof. Cornett served as a panelist at a public forum on the work of the Tennessee Supreme Court Commission on Gender Fairness on Oct. 9, 1997, at Vanderbilt University School of Law in Nashville.

Melinda Davis and Kelly Browne's movie review of "A Time to Kill" was published in the Winter 1997 issue of the American Association of Law Libraries Academic Law Libraries Special Interest Section Newsletter.

Amy Hess became editor-in-chief of the *Real Property, Probate & Trust Journal* in August 1997. Micki Fox, Law Review business manager, also joined the Journal on that date as its print manager. They are the first members of the Journal's professional staff who are unaffiliated with the University of South Carolina since the student editorial board was located there in 1990. Prof. Hess gave two CLE lectures. On Oct. 10, she joined UT alumni Jonathan Reed and Marshall Peterson in presenting an all day program at the UT law

school on Practice Under the New Tennessee Probate Code. It was the first in what the group hopes will be a series of CLE programs on tax and estates subjects, the proceeds of which will eventually be used to endow a Durward S. Jones Chaired Professorship in Law. On Oct. 23, Prof. Hess made a shorter CLE presentation to the Chattanooga Estate Planning Council called "Are My Old Will Forms Still Good?: Estate and Gift Tax Changes in the Taxpayer Relief Act of 1997."

Don Leatherman appeared on a panel at the ABA tax section meeting in Phoenix, Ariz., in January that discussed current developments and some tax transactional planning issues involving affiliated groups. Also in January, a staff member of the Joint Committee on Taxation asked Prof. Leatherman for suggestions for legislative proposals.

Bob Lloyd's article, "Lender Liability For Wrongful Repossession," was published in Volume 114, Number 7 of the *Banking Law Journal*. Prof. Lloyd spoke on "Programming in ToolBook 3.0" at the Conference of Law School Computing sponsored by the Center for Computer-Assisted Legal Instruction (CALI). His presentation was broadcast on the Internet. Prof. Lloyd has been appointed chair of the task force studying real estate receivables as part of the redrafting of Article 9 of the UCC.

Carl Pierce is the new director of the Center for Entrepreneurial Law. **Bob Lloyd**, the Center's first director, stepped down over the summer. On July 17, at the Tennessee Bar Association Annual Convention held in Sandestin, Fla., Prof. Pierce was awarded the 1997 President's Award by TBA President J.Daniel Breen.

Loretta Price is the newest faculty member in the Law Library. Prof. Price was named assistant professor and acquisitions librarian over the summer. She has worked in libraries on and off since the late 1960s when she was an acquisitions and serials assistant at UT's main library. Since 1989, she has worked at the Law Library as a technical assistant in cataloging and acquisitions, while getting a graduate degree in Library and Information Science in 1994. Prof. Price is currently working on the preparation of a bibliography publication on women and the law.

Glenn Reynolds had the second edition of *Outer Space: Problems of Law and Policy* (Harper Collins Westview, 1997), co-authored with Robert P. Merges of Boalt Hall Law School, published. Prof. Reynolds appeared on the NBC "Today" show July 1 discussing space law. He was quoted in *U.S. News* July 7 regarding the Supreme Court's justfinished term. And he appeared on ABC/Discovery News July 11, also discussing space law. Prof. Reynolds' article, "It Takes A Militia: A Communitarian Case for Compulsory Arms Bearing" (co-authored with UT alumnus **Brannon Denning**) appears in the *William & Mary Bill of Rights Journal*. The cite is 5 Wm. & Mary. Bill of Rights J. 185 (1996). Reynolds' article "Comfortably Penumbral," also co-authored with Denning, has been accepted by the *Boston University Law Re*-

Dean Hoover received an A.B. degree in philosophy from the University of Michigan in 1959 and a J.D. degree from the Brooklyn Law School in 1969, graduating fourth in a class of 330. She worked as a law clerk for the United States District Court for the Southern District of New York (1969-70), a staff attorney for East New York Legal Services (1970-72), an attorney in family law with Community for Legal Services in New York City (1972-73), a managing attorney for MFY Legal Services in New York City (1973-74), and a law clerk with the Tennessee Court of Criminal Appeals (1976) prior to entering academia.

Dean Hoover joined the faculty of the UT College of Law in August 1976 as assistant dean and instructor of law. She became the associate dean for student affairs in 1980.

Dean Hoover is best known to the current generation of the law school family as the guiding force behind the move from the old law school building in 1994 and back into the new building this

Rivkin had an essay published in Tools to Aid Environmental Decision-Making (SpringerVerlag forthcoming 1998). Rivkin was presented with an award "for the gift of your time and expertise in the service of people in the Cumberland Mountains and throughout Tennessee" at the 25th anniversary celebration of Save Our Cumberland Mountains (SOCM).

Barbara Stark presented a paper, "Critical Race Theory and Human Rights: Walking Our Boundaries," at the Critical Race Theory Conference at Yale in November. Prof. Stark's article, "Guys and Dolls: Remedial Nurturing Skills in Post-Divorce Practice, Feminist Theory and Family Law Doctrine," will be published in the *Hofstra Law Review*. First two Leech Scholarships awarded to Barker, Murphy

The first two William M. Leech, Jr. Memorial Scholarships have been awarded at the University of Tennessee College of Law. Allison Barker of Crossville and Aaron Murphy of Knoxville are the 1997-98 recipients of the state's largest grants for law students.

Barker, a third-year law student, graduated cum laude from Tennessee Technological University in 1995 with a degree in business administration and personnel and labor relations. She is a member of the UT Student Bar Association and the Law and Medicine Society and has served as a student advisor and a student advocate for the homeless.

Murphy, a second-year law student, received a degree in psychology from Chapman University in Orange, Calif., in 1995, graduating magna cum laude. He was a 1997 summer associate with the Knoxville firm of Lewis, King, Kreig, Waldrop & Catron and was the recipient of the 1996 Arthur B. Hyman Memorial Scholarship at the UT College of Law.

The Leech scholarships were established in July 1997 by the Nashville Community Foundation's McWhorter Foundation Advised Fund to honor the former State Attorney General and UT law alumnus. Mr. Leech, a 1966 UT law graduate, died in June 1996.

The Leech Scholarships will award \$48,000 to six students per year — three each at the UT College of Law and the University of Memphis' Cecil C. Humphreys School of Law. Each student will receive \$8,000.

Four initial scholarships — one to a second- and third-year law student at each school —were awarded for the '97-98 academic year. Beginning in 1998, an additional scholarship will be awarded to a first-year student at each school.

The Leech Scholarships are awarded to students who reflect the dedication to professionalism in the law and public service exemplified by Mr. Leech, Tennessee Attorney General and lawyer. Mr. Leech served as Attorney General and Reporter of the State of Tennessee from 1978 through 1984. After returning to private practice, he became a senior member with Waller Lansden Dortch & Davis, where he represented corporate clients until his death in 1996.

To qualify for a scholarship, students must be Tennessee residents and demonstrate financial need, a high likelihood of academic and professional success, an effort to overcome challenging personal obstacles, and a commitment to public service.

UT hosts Region VII Moot Court

The University of Tennessee College of law hosted the Region VII National Moot Court competition Nov. 20-22, 1997. Eleven schools from throughout the Southeast competed for two spots in the national competition to be held in New York City in January.

UT's team of Chris Cain, Elizabeth Foss and Lori Ritter narrowly missed a trip to new York by finishing third. The trio defeated Mississippi College, Southern University, Loyola University of New Orleans, and Vanderbilt, while losing to Memphis and Tulane in the double-elimination competition.

Alabama and Tulane took the top two spots.

Tennessee was coached by Prof. and Associate Dean John Sobieski, Jr. and '97 alumna Booth Andrews. Prof. Joseph G. Cook served as regional sponsor for the event.

Tennessee Law Review is ranked 41st nationally

The *Tennessee Law Review*, the UT College of Law's legal journal, has been ranked 41st nationally by two law professors at Nova Southeastern University.

The professors, Robert M. Jarvis and Phyllis G. Coleman, ranked 161 journals based on the national prominence of the authors of their lead articles. The findings were published in the 1997 spring issue of the *Arizona Law Review*. The *Columbia Law Review* topped the list with the *Harvard Law Review* second.

The *Tennessee Law Review* is published quarterly by UT law students and includes articles by professors, students, and practitioners on a wide variety of legal topics.

Admissions Networking

The Admissions Office began preparing for the 1998 application year well before the books on the 1997 admission process were closed. Over 40 colleges and universities were visited and hundreds of candidates were met in person by admissions representatives. Numerous additional contacts were made through publications of the College of Law and through the College of Law home page on the World Wide Web.

What role can our alumni play in these outreach efforts? Our alumni are one of our biggest recruitment tools as they offer personal words of encouragement to candidates who are considering law school. We also ask several alumni each year to be profiled in our recruitment brochure, the *Applicant Guide*.

An outreach activity that proved successful in 1996 and again in 1997 was our Alumni Networker program. Over 50 alumni agreed to write letters to admitted candidates in their area to encourage their acceptance of our offer of admission. We need more volunteers for this year from all over the US -- particularly alumni who are located in Chattanooga, upper East Tennessee, North Carolina, Georgia, and Virginia.

Technology becomes greater ally in UT admissions process

The UT College of Law now offers several options utilizing the latest in technology for prospective students.

The latest addition to the College's web page (www.law.utk.edu) allows students anywhere in the world with internet access and Acrobat Reader software to print all of the forms necessary to apply to the UT College of Law, fill them out at home, and then mail them to the College. Students without Acrobat Reader have the option of requesting, via e-mail, that application forms by mailed to them.

These latest additions to the College's admission efforts are the result of the work of Bill Hodges, the College's computer, electronic services, and networking manager. Hodges is now working on a process that will allow prospective students to fill out the forms and return them online.

"We've come light years in the last three years," said Karen Britton, director of admissions and financial aid. "When I came to UT in 1994 our procedure was to gather names and addresses and send students a *Bulletin* by bulk mail with an application stuffed in the back. It took weeks for students to receive the materials. In some instances they never received them."

The College now has a comprehensive Applicant Guide and

application packet that is promptly mailed to prospective students. All of the pertinent information in the *Applicant Guide* is also included on the College's web page, which has been up and running for the past year. The page provides information such as academic requirements and programs, admissions procedures, fees, financial aid, and faculty credentials.

Information about the UT College of Law is also included on a CD Rom that students may order from the Law School Admission Council (www.lsas.org). The CD includes much of the information contained in the *Applicant Guide* and on the web page, including application forms.



Career Services

Joann Gillespie Rothery retired from the College of Law at the end of December after 13 years as Director of Career Services.

"Though I will so miss the students, employers and colleagues that have been a part of this job that I've enjoyed tremendously, it's exciting to know that my successor is such a dynamic and talented person," Rothery said.

In January, Karen Reagan Britton assumed a new title, reflecting additional responsibilities, as Director of Admissions and Career Services.

Britton has been director of admissions and financial aid at the College of Law since 1994. Prior to moving back home to Knoxville, she worked for eight years at Bass, Berry & Sims in Nashville, directing their administrative areas of attorney recruitment and hiring, associate development, attorney training, and client development. Britton has held several leadership positions with the National Association for Law Placement (NALP) and is a frequent speaker at professional meetings in the field of law career services.

Britton holds the M.S. in higher education, and in May of 1998 will complete her doctoral course work in leadership studies in higher education, with emphases in law and management, and counselor education and counseling psychology. Her doctoral dissertation will focus on the development of a career development concept map for law students, tracing influences on initial career choice from the time of admission to law school through the initial job choice of a new law graduate.

"When Joann told me of her plans, I immediately thought of Karen Britton as a natural to lead the offices of Career Services and Admissions and Financial Aid," said Dean Richard Wirtz. "Both operations will remain in their current locations in the College of Law buillding, and Karen promised not to ask for a stair climber machine for Christmas since she will maintain offices on two floors."

When asked about the transition, Britton said, "The organizational structure and programs of the two operations are complementary. When we counsel candidates for admission, their career development is almost always a part of the discussion. With extremely capable, experienced staff members in both operations, we are looking forward to the opportunity to keep serving the students we admit as they plan their careers during their three years of law school."

Development Report

It was another great year for the UT College of Law Office of Development and Alumni Affairs. From July 1, 1996, to June 30, 1997, \$1,031,823 in cash gifts and \$830,602 in pledges were received. Thank you very much for your incredible support!

The College of Law is pleased to report the following, which reflects gifts and pledges reported between July 1, 1996, and June 30, 1997:

NEW ENDOWMENTS

James R. & Nell W. Cunningham Excellence in Legal Writing Award Endowment

Mr. James R. Cunningham and his wife Nell, have established an award endowment for the author of the best scholarly writing by an upperclass student enrolled in the College of Law. Mr. Cunningham is a native of Union City, Tenn., and graduated from the law school in 1947. Prior to his graduation from law school, he was on active duty in the Army during World War II and participated in nine major amphibious landings in the Pacific. On June 1, 1950, he was married to Nell Senter Watkins. He spent five years in private practice and subsequently joined the Legal Division of Proctor and Gamble where he headed the Litigation Section at the time of his retirement. The legal writing award will be presented at the College of Law Annual Awards Banquet held in the fall of each year.

William W. Hawkins Scholarship Endowment

E.G. Moody, John S. Bingham and J. David Miller have established a scholarship endowment in memory of their law firm partner William W. Hawkins. Mr. Hawkins was a native of Jefferson County, Tenn., and began attending law school in 1949. He left school in 1950 to serve his country in the United States Air Force where he served until 1953. Afterward, he returned to UT and was awarded his law degree in 1955. While in school, Mr. Hawkins worked several jobs to help pay expenses. Having worked as an ambulance driver, police officer, and later an insurance adjuster, he maintained a life-long affinity for anyone employed in these professions. The scholarship established in William W. Hawkins memory gives preference to individuals wanting to pursue a law degree from these professions. In 1957, Mr. Hawkins and attorney Carl Miller established a law practice that evolved into today's law firm of Hawkins, Moody, Bingham & Miller.

William M. Leech Jr. Memorial Endowment

Waller Lansden Dortch & Davis, on behalf of General Leech's many friends has established the William M. Leech, Jr. Public Service Prize in honor of his outstanding service to his profession and to the State of Tennessee. William M. Leech, Jr. a 1966 graduate of the UT College of Law served with distinction as Attorney General and Reporter for the State of Tennessee from 1978 to 1984. He was a partner of Waller Lansden Dortch & Davis and was practicing in Columbia and Nashville at the time of his death in 1996.

William M. Leech Memorial Scholarship

The William M. Leech Memorial Scholarship was established by the R. Clayton McWhorter Foundation Advised Fund of the Nashville Community Foundation to memorialize and honor the 1966 UT law graduate for his outstanding service to his profession and to the State of Tennessee. The foundation will fund three scholarships awarded to a first-year, second-year, and thirdyear law school student. Mr. R. Clayton McWhorter and Mr. Charles Trost were the catalysts for this scholarship.

Robert E. Pryor Award of Excellence in Advocacy

The Robert E. Pryor Award of Excellence in Advocacy will be available to students who are in the advocacy program at the UT College of Law. The award will be presented to the top student in the advocacy program, and the selection of this award shall be based on academic performance, classroom performance, promise and demonstrated commitment to professionalism, and ethical conduct. The award was established to honor the leadership of Robert E. Pryor and his untiring commitment to the education of advocates.

Norman B. Sayne Scholarship Endowment

The Norman B. Sayne Scholarship was established by Mrs. R. Franklin Edwards in memory of her nephew, Norman Brooks Sayne. Norman was born in Knoxville, Tenn., in 1934 and served in the Naval Aviation branch of the United States Navy. After his discharge from the Navy, he entered the UT College of Law. In September 1962, before beginning his third year of law school, he was engaged in naval aviation reserve training when his plane crashed and he was killed. The scholarship is available to a UT law student who has demonstrated successful academic performance and professional promise.

Thomas A. Tansil, Jr. Scholarship Endowment

The Thomas A. Tansil, Jr. Scholarship was created by Thomas A. Tansil, Jr., a 1995 UT Law graduate. Mr. Tansil grew up in Greenfield, Tenn., and attended Dyersburg State Community College on a baseball and academic scholarship. Upon graduation he enrolled at The University of Tennessee, Martin as a University National Alumni Scholar where he majored in Criminal Justice. Afterward, he received his J.D. degree in 1995 from the UT College of Law and was involved in various activities including the Student Bar Association, the Ray H. Jenkins Trial Competi-

tion, and served as Vice-Chairman of the Moot Court Board. The scholarship, once fully funded, will be awarded to students from Tennessee who have demonstrated successful academic performance.

The Judge Robert L. and Florence M. Taylor Memorial Public Service Endowment Fund

The Judge Robert L. and Florence M. Taylor Memorial Public Service Endowment Fund was created in 1996 by Ann Taylor in memory of her parents. Judge Taylor was a federal judge and served on the Bench in the Eastern District of Tennessee from 1949 until 1985. He held court outside of Tennessee in cities such as Miami and New York, and was named twice by the Chief Justice in cases involving prominent figures in Illinois and Maryland. Florence McCain Taylor was married to Judge Taylor for 54 years and traveled with him whenever he held court out of state. The scholarship, once fully funded, will be used to encourage and support College of Law students' activities in public service.



Career Services

The ending of the 1996-97 academic year was more like a beginning as we moved to the Taylor Wing of the handsome new College of Law building. Career Services moved up—from its previous home in the corner of the basement to offices across from the Dean's suite on the second floor. Alumni will remember these renovated quarters in the old building as the area behind the circulation desk in the law library—everything has changed except the large supporting beams which now are covered with bulletin boards bearing job notices and interview sign-up sheets for on-campus interviewing.

Our last year in transition continued with the challenges of communicating with students and colleagues scattered all over the campus. The challenges weighed more heavily with students who arrived at our offices from these outposts burdened with tomes of law collected in huge back packs. But as all challenges prompt growth, the Career Services staff and students were pressed to rely more quickly and completely on the latest telecommunications equipment, with e-mail and Web sites gaining on faxes and answering machines. At the same time, old favorites—such as notices taped to the walls and hot pink slips placed in student mailboxes were not abandoned.

Trends noted during the year included rising student interest in the practice of international law, evidenced not only by individual inquiries about careers and opportunities for study abroad during the summer, but also by a very active International Law Society. On a different note, many others expressed interest in striking out on their own, not because they would have no other opportunities, but more so because they wished to have control of their work. A Career Services seminar entitled "Nuts and Bolts for Starting your Own Practice," presented by alumnus Jim Pointe of Rogersville, proved a popular event.

Another highlight was an appearance by Kimm Walton, or the "Job Goddess" as she is called on *The National Law Journal's* Web site. Author of Harcourt Brace's widely read *Guerilla Tactics for Getting the Legal Job of Your Dreams...Regardless of Your Grades, Your School, or Your Work Experience*, Ms. Walton made a lively, motivational presentation that emphasized the value of networking for one's arsenal of job hunting tools. Pacing the dais wearing a striped, knit shirt atop black leather pants, the author assured students that one doesn't have to know people in high places to network. She followed with an anecdote about the successful referral of an unemployed law graduate by trash collectors for his apartment complex to attorneys living a couple of doors down. The Student Bar Association co-sponsored and financed the event.

While on-campus recruiting activity remained near the same level as the previous year, a budding resurgence in the strength of the legal job market was signaled by a year-end count of employer listings soliciting direct contact from students and graduates. Over 346 listings were made during the 1996-97 academic year compared to 246 for 1995-96. With spirits buoyed by new surroundings and encouraging statistics for the Class of 1997, the Career Services staff looked forward to a new school year filled with enthusiasm and high expectations.

EMPLOYMENT STATISTICS FOR THE CLASS OF 1996

The annual employment survey compiled by the Career Services office for the National Association for Law Placement (NALP) for the Class of 1996 showed the first distinctive drop in employment for graduates since the Class of 1991. Average salaries, however, showed a slight increase.

Within nine months of graduation, 88 percent of UT's Class of 1996 whose status was known had accepted employment, compared to 92 percent of the Class of 1995. Hopefully this decline can be attributed to a larger than usual class size (157 whose status was known, compared to an average of 148 graduates in the Classes of 1991-95), and the change that NALP made in defining the population of a "graduating class" (from August, December and May matriculants to December, May and August matriculants.) As a result of this change, seven employed August 1995 graduates were removed from our statistics for the Class of 1996 and do not appear in any information reported to NALP.

Nationwide, employment for law graduates was up slightly to 88 percent of the Class of 1996, compared to 87 percent from the previous year.

Twelve percent of both UT's Class of 1996 (19 graduates) and the nationwide Class of 1996 reported that they were unemployed and/or seeking work. Of the unemployed UT law graduates, eight were seeking work (the same number as the previous year), seven were not seeking work, and four became full-time degree-seeking students enrolled predominately in LL.M. programs.

Statistics for 138 employed UT graduates by type of initial employer reveal the following breakdowns: 63 percent (87 people) entered private practice; 20 percent (27 people) accepted government-related positions; 15 percent (20 people) were employed in business and industry; one percent (2 people) accepted public interest positions; and one percent (2 people) were employed in academia.

Forty-five percent of graduates employed full-time provided salary information, revealing a range of \$21,500 to \$57,500. The average annual salary of \$37,868 reported by UT graduates for all locations and all positions was up from \$36,192 for the Class of 1995.

For law school graduates nationwide, the 1996 average annual salary was \$46,499, up slightly from \$45,590 for the previous year. The median starting salary for UT graduates was \$37,000, compared to \$40,000 for graduates nationwide.



The Law Library

Anyone who enters the Law Library is immediately aware of the major accomplishment of its faculty and staff over the past year. 1996 was definitely the year of the on-line catalog, and 1997 will go down in history as the year of the new facility. Remarkable efforts and amounts of time, energy, talent, and personal sacrifice have, over the past several years, been invested in making the Law Library a reality for its various user groups.

After almost two years in a cramped transition facility, during which a percentage of the collection was housed in two off-site facilities and during which full library services were provided to its users, the new facility was finally ready to accommodate the move of staff, faculty, collection, equipment, students and other users. Without doubt, the Law Library's spectacular new physical facility provides venue for the finest law library ever to grace the State of Tennessee. Development plans and policies have been formulated to reflect the value of excellence in legal education which are intrinsic to the day-to-day work of those who share in the mission of the Law Library.

The mission of the library is three-fold and is determined by the identify of its three constituent user groups. First and foremost, the mission is to meet the unique academic and research needs of the students and faculty of the College Law. No less significant is the Law Library's mission to serve all members of the University community by providing for their frequent and regular needs for legal information and legal research instruction. Finally, as the flagship legal research resource of the state University, the Law Library proudly serves both the broader community and the legal community of the immediate area, the state and the region by providing, through various hard copy and electronic means, the legal and government information access required by these variant user groups.

Focus on services to the legal community is anchored on the development and maintenance of a practice-oriented collection and document delivery services, along with professional-level instructional programs. Service focus for the general public is anchored in the Government Documents Depository, a growing selfhelp collection, and individualized reference assistance. Funding levels, however, have been damaged by recent budget cuts to an extent which is difficult to assess at this juncture; and, most certainly, further cuts will erode irreparably both percent advancements and previous groundwork which has been developed over the years. The five-year comparison chart illustrates current collection growth and acquisition expenditures. The Law Library now contains 436,129 volumes and microforms volume equivalents. This is a 3.6% increase over the previous year and a 19.3% increase over the past five years. Some of the decreasing growth in the collection can be attributed to increased materials costs, especially for subscription items such as reporters, looseleaf services, and other update services.

It is, however, the growth of technology which will mark the Law Library's transport across the symbolic bridge into the next century. Three years ago, the Law Library negotiated a major leap by assuming the leadership and responsibility for the provision of electronic services and communications throughout the College of Law and between the College and the rest of the world. As a result of this brave step, the College now boasts a local area network with Internet access, two computer labs complete with 55 computers, the Law Library online catalog, the College of Law web site (http://www.law.utk.edu), e-mail, and personal computers on every faculty and staff desk. The capacity for outreach by the College and the Law Library is determined, almost entirely at this point, by the resources available for development of this technology base already in place, Staffing in this area has become painfully inadequate, while the fees for computer ports in the new facility have become staggering. A staff of two supports 200 personal computers, 35 networked cd-rom drives, file servers, mini computers, operating system, and application software. In spite of these drawbacks, plans and work continue for the implementation of the circulation, acquisitions, and serials modules of the automated system, along with exciting enhancements.

In spite of the monumental nature of the Law Library's recent accomplishments. The faculty continue to make significant service contributions to the College, the University, and the Community, while finding time and energy through personal sacrifice to engineer the development, completion, and publication of research projects. Several Law Library faculty participate in the governance of the University community through their service with forces such as the Faculty Senate and its various committees, the Commission for Women and its array of committees, the Graduate Council and its committees, and the University's Evaluation of Administrators Process. The Law Library faculty continues to participate also in the governance of the College through their service on the College's committees including Dean Search Committees, director and department head search committees, self-study committees, and other continuing committees such as long-range planning, admissions, readmissions, scholarship and financial aid, technology and information, governance, facilities, building, transition, Clinic Advisory and of course, promotion and tenure.

Topical areas of research and scholarship which are currently in-process, include the insanity defense, prison and institutional law library services, Tennessee legal research, Knoxville legal history, law library history and development, and women and the law. Over this past year, particularly, the Law Library faculty has proven itself to be an energetic, service-oriented and contributing group of professionals and academics with a diverse and interesting array of scholarship interests. As a result of their continuing devotion to these continuing responsibilities, along with their massive efforts which finally resulted in the library's move into the new facility, each member of the Law Library Faculty was recently awarded the College's 1997 Carden Award for Outstanding Institutional Service.

All-in-all, this year has been a positive and eventful one for the Law Library and its user constituency. The tasks before the library at the year's beginning were overwhelming and daunting, but the faculty and staff, in an impressive display of teamwork
