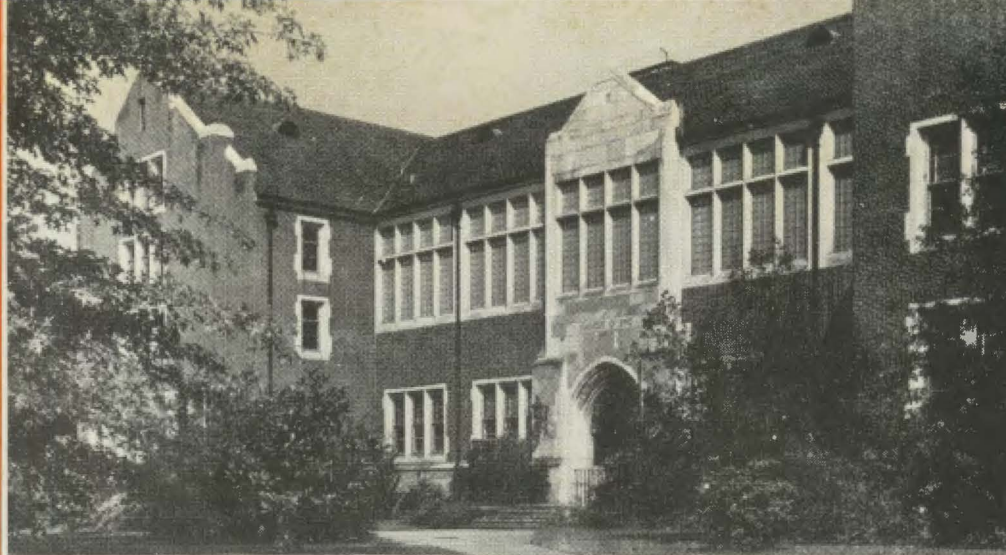

## *A Message from the Dean*

# PRIMARY PROBLEMS CONFRONTING LAW SCHOOLS

During the past few years one of the primary problems confronting law schools has been escalating enrollments. This problem is resolved, in some measure, by selective admissions to the entering class. Here, at the College of Law, in the Fall Quarter 1966 we accepted 156 students as the entering class; the total enrollment was 480. This number so overtaxed our physical facilities that in the Fall of 1967 we were forced to limit the entering class to 125; this still gave us a total enrollment of 470. It was then determined that, considering our facilities, under no circumstances should the over-all enrollment in the future be permitted to exceed 450.

In 1968, however, our problem was resolved, temporarily at least, by changes in the Selective Service regulations. On the undergraduate level, a student satisfactorily pursuing a full-time course towards his first degree is now entitled to a Class II-S deferment only until he graduates, or drops out of school, or reaches the age of 24. The Law College, however, is classified as a professional and graduate school and deferments within that classification are more restricted. The rule-of-thumb set forth in the Tennessee Operations Manual, Tennessee State Headquarters, Selective Service System, for law students is as follows:

"If he entered the professional school the first time in the late summer or early fall of 1967 he was eligible for deferment for one year only. Such deferments cannot be extended. If he entered during the official Summer Session, Fall Quarter or Semester of 1967 or before, or if he resumes his studies before 1 October 1967 after having been in Class II-A or IV-D he is eligible for further deferment until the end of the normal time required for him to complete the course."

This means that the law students who are currently in the first quarter of their senior year will be deferred upon their request until they graduate in June and have the opportunity to take the bar examination.

The new deferment policy is having a substantial impact on our first and second year enrollment. A number of

the students report that their draft boards have put them on notice that they will be called for active duty upon the completion of the Fall Quarter. Others who had signed with Reserve Units or the National Guard have already been called upon for either six months or three months of active duty training. These students are given a leave of absence from the Law College from the time they receive their orders.

Faced with a projection based on so many variables, the College of Law, in common with other law schools, accepted a higher number of applicants for the Fall Quarter, 1968, than in past years. Many of our applicants, however, decided not to enroll, preferring to fulfill their military obligation rather than attend law school on a tenuous quarter-to-quarter basis while awaiting a draft call. Thus, out of a total of 194 applicants accepted for the Fall Quarter, only 70 registered at the Law College. This reduced our total enrollment at the beginning of the present Quarter to 405, compared to the total during the Fall of 1967 of 470.

The new draft regulations also have had an impact on our faculty. Professor Donald T. Weckstein, on leave of absence for the academic year 1967-1968, was a visiting professor at the University of Connecticut School of Law, where he had previously served as a member of the faculty. In February, 1968, he submitted his resignation as a member of our faculty. The vacancy created by Professor Weckstein's resignation has not been filled due to uncertainty as to the continuing effect of the draft rules on our enrollment.

Prior to Professor Weckstein's resignation, Professor Thomas G. Roady, Jr., a Professor of Law at Vanderbilt University School of Law, accepted an invitation to join our faculty. As many of our alumni will recall, Professor Roady started his law teaching career in 1949 at the University of Tennessee College of Law. He remained here for two years and then served as Professor and Assistant Dean, University of Washington, St. Louis, 1951-52; partner of the law firm of McDonald & Roady, Carrollton, Illinois, 1952-1956; Visiting Professor, University of Missouri, 1954; and Professor, Vanderbilt University School of Law, 1956-1968.

We have also to report that Dean-Emeritus William H. Wicker, who retired from the University of Tennessee in August 1967, accepted a one-year appointment as Visiting

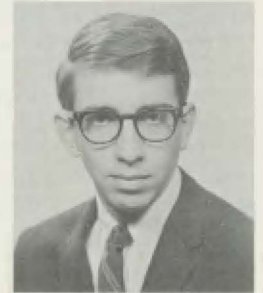

## Message from the Dean

Professor at Drake University for the year 1967-68. He has also accepted a new appointment at Drake for the year 1968-69.

Our long time faculty member, Hal F. Burk, who taught taxation and estate planning, suffered a serious heart attack in June 1968. Professor Burk has made a good recovery and is now able to attend to his private practice but feels that he must give up his teaching.

We are proud of our National Appellate Moot Court Team: George Derryberry, Chattanooga; Houston Gordon, Covington; and William Humphreys, Memphis. Our team and the team from Vanderbilt were the finalists in the regional competition held in mid-November between teams representing the law schools in Indiana, Kentucky, and Tennessee. Our U-T team and the Vanderbilt team, who won the finals, will represent the region in New York in the Nationals to be held in mid-December, 1968. The appellate arguments center on the legality of the war in Vietnam.

Scholarship funds are always good news features. In 1967 Mrs. A. J. Graves established the A. J. Graves Memorial Scholarship Fund in memory of her husband, an alumnus of the College of Law. In the Spring of 1968, Mrs. Graves died and by her will endowed the A. J. Graves Memorial Scholarship Fund in the amount of \$10,000 to keep the scholarship operating.

We are also pleased to announce that on June 12, 1967 Judge George S. Child, Robert M. Child, and John L. Child established the George S. Child, Sr. Memorial Scholarship. The Scholarship award is in the amount of \$300 per year.

Our institute programs, presented in cooperation with the Tennessee Bar Association and local bar groups, continue apace. In May 1968, our Annual Southeastern Trial Lawyers Institute was most successful. We are planning our next Institute to be held in April or May, 1969. In October and November of this year, the College of Law, the College of Business Administration Department of Accounting, and the Internal Revenue Service co-sponsored a two-day tax institute, which was held in Nashville and in Knoxville. Then in December 1968, the College of Law, the College of Business Administration, the Tennessee Bar Association, The Tennessee Society of Certified Public Accountants, the Tennessee Society of Public Accountants in cooperation with the Arkansas Society of Certified Public

Accountants, The Arkansas Society of Public Accountants and the Arkansas Bar Association are sponsoring the Annual Tax Institute at the Peabody Hotel, Memphis.

In January 1969, the American Trial Lawyers Association will present at the College of Law a one-day program on Trial Advocacy designed especially for law students. The program this year will be Advocacy in Criminal Trials and will consist of a mock trial and discussion period. Our past institutes of this type, designed especially for student interest and instruction, have been highly successful.

Now a reminder about your J.D. degrees. More than 1500 applications for new diplomas showing the Doctor of Jurisprudence degree have been issued to alumni. Applications are still being received; interested alumni are asked to send in their applications as soon as possible.

In closing this report I wish, as I have so often in the past, to extend to all our alumni and their friends a cordial invitation to visit us and learn about our changing and expanding programs and about our plans for the future of the College of Law.

## National Moot Court Team Goes To New York

The Region 16 Competition for the National Appellate Moot Court Competition was held in Knoxville on November 14 and 15. Teams representing law schools in Tennessee, Kentucky, and Indiana argued a case involving an action brought by a draftee questioning the legality of the United States' participation in the war in Vietnam. U-T's team, composed of George Derryberry, Chattanooga, Houston Gordon, Covington, and William Humphreys, Memphis, defeated the University of Indiana at Indianapolis and the University of Kentucky in the first two rounds. In the final round Tennessee faced Vanderbilt before a distinguished bench composed of The Honorable Hamilton Burnett, Chief Justice, Tennessee Supreme Court and two Federal judges, The Honorable Robert L. Taylor, Chief Judge, Eastern District, and The Honorable William E. Miller, Chief Judge, Middle District, Tennessee. Vanderbilt won a two to one decision, but both U-T and Vanderbilt, as regional finalists, will go to New York for the national competition on December 16.

## Best Advocates Selected In Trial Moot Court

During the summer and fall quarters of 1968, two separate sections of Trial Moot Court were conducted. Senior students in their 8th or 9th quarter participated, acting as counsel in actual case fact situations, with freshman students composing a jury in each trial. Two judges from the Third Circuit Court for the State of Tennessee, Knox County, The Honorable T. Edward Cole, Judge of Division II, and The Honorable James M. Haynes, Judge of Division III, directed the two respective summer sections and presided in the trials.

At the end of the summer quarter, the trial attorneys who demonstrated outstanding ability were selected from each section. The selections were made on such bases as case preparation, oral delivery, general courtroom demeanor, witness examination technique, presentation of argument to the jury, and particularly the ability to think quickly and react properly to the unexpected situation.

Each student participating as trial counsel in the program was also required to submit a report on an actual civil case observed in a state or federal court during each quarter.

Leading students in Judge Cole's summer section, in the order of their selection, were Jess Campbell, George Atwell, Timothy Moratzka, and Fred Lewis. Superior students chosen in Judge Haynes' summer section were Dalton Townsend, Larry Parrish, Denny Mobbs, and Thomas F. Smith.

The fall quarter program was divided into three sections. Judges Cole, Haynes and The Honorable Chester R. Mahood, Judge of Division I of the Third Circuit, presided over the trials.

Superior trial attorneys in Judge Cole's fall section, in the order of their selection, were George Atwell, Ralph Harwell, and Robert Rochelle. Leaders in Judge Haynes' section were Bart Mallory, Forrest Norville, John Wilson, and Robert Pryor. John Slack, Gerald Fudge, Stephen Lawrence, and Steve Bovell were top advocates in Judge Mahood's section.
