Barbara Stark, Associate Professor of Law

After graduating with a law degree from New York University, Professor Stark devoted four years to practice in legal services programs and six years to private practice before returning to school to earn an LL.M. from Columbia. She comes to UT from the law faculty at Rutgers University, where she has been coordinating the legal writing program and assisting in the administration of the Constitutional Litigation Clinic. She has written widely on women's issues, civil rights, and international law. Professor Stark will teach Legal Process in the fall, and Public International Law and the International Law Seminar in the spring, and will serve on the Clinic Advisory Committee at the College of Law. Gregory M. Stein, Associate Professor of Law Professor Stein earned his undergraduate degree at Harvard and his law degree from Columbia, where he was a senior editor to the Law Review. For the past three years he has been with the firm of Paul, Weiss, Rifkind, Wharton & Garrison in New York City, working primarily in the areas of acquisition and disposition of real property and the financing of land transactions. He has also represented tenants pro bono publico in housing court and administrative proceedings. Professor Stein will teach Land Finance this fall, the Land Acquisition & Development Seminar and Property in the spring, and will serve on the Library Advisory Committee at the College of Law.

Judy M. Cornett, Associate Professor of Law

Professor Cornett earned her B.A. and J.D. degrees from the University of Tennessee, both with highest honors, and was Editor-in-Chief of the Tennessee Law Review. After a year as a judicial clerk on the D.C. Circuit and several years as an attorney in Knoxville (and sometime adjunct faculty member of the College of Law), she returned to school to earn an M.A. in English from the University of Virginia and is currently working toward her Ph.D. She will each Law and Literature this fall.

Lenny L. Croce, Associate Professor of Law

Professor Croce attended Baylor University and Vanderbilt Law School, where he was President of the Vanderbilt Legal Aid Society. Since 1978 he has been Managing and Senior Attorney in the Oak Ridge office of Rural Services of Tennessee, a multi-county legal services program. Professor Croce has broad-ranging experience in civil and criminal litigation at all levels in the state and federal systems, in cases ranging from civil class actions to death penalty cases. He will teach Civil Advocacy this fall.

Mary M. Farmer, Associate Professor of Law

Professor Farmer, Class of 1980, is a partner in the Knoxville firm of Lewis, King, Krieg & Waldrop. Her practice centers on civil litigation, primarily in the areas of bankruptcy, banking, and commercial law. She has been active in state and local bar and civic affairs, and is a member of the East Tennessee Lawyers' Association for Women since its formation. Professor Farmer will teach a section of Trial Practice in the fall.

Robert L. Jolley, Jr., Associate Professor of Law

Professor Jolley, a University of Chicago law graduate, has served as Assistant Attorney General and Senior Assistant Attorney General for the State of Tennessee. He has been the Assistant District Attorney General in Knoxville since 1982. He has wide experience in the trial of both civil and criminal cases, including approximately one hundred jury trials. He will teach a section of Trial Practice in the fall.

John A. Walker, Associate Professor of Law

Professor Walker, a Columbia University law graduate and past Columbia Journal of Transnational Law Editor-in-Chief, is a leading commercial law practitioner in Knoxville. This fall he will teach a new course in Banking Law.

Marcia C. Huie, Professor of Law


Professor Huie will be here on leave from St. Mary's University School of Law, San Antonio, Texas, where she teaches courses in Contracts and Commercial Law. She holds two degrees from UT, a J.D. from Memphis State, and an LL.M. from Cambridge University in England. Professor Huie clerked for the Tennessee Court of Appeals and was in private practice for three years in Memphis before she began teaching. She has written extensively on Commercial Law and Antitrust. This fall she will each Commercial Law and Contracts I.

Scott Miller, Assistant Professor of Law

Professor Miller received his J.D. from the University of Minnesota Law School. He is currently on leave from West Publishing Company of St. Paul, Minnesota (where he is a reference specialist attorney) to teach Legal Process in the fall.

Kenneth L. Penegar, Professor of Law

The former Dean of UT College of Law, Ken Penegar earned his J.D. degree at the University of North Carolina and his LL.M. at Yale. After a year as law clerk on the D.C. Circuit, he returned to North Carolina to join the law faculty. In 1971 he accepted UT's invitation to become Professor and Dean. After 15 years at UT, he accepted the position of Dean at Southern Methodist University where he is still on the faculty. Dean Penegar will teach Criminal Law and Jurisprudence.

... had an article, "S = E - (O + O + O ...)" published in the Spring 1990 issue of the Yale Law Report.


... has had two of his articles cited in U.S.C.A. in the Law Review Commentaries' annotations to three statutes.

CONSTITUTION WEEK - SEPTEMBER 17 - 23, 1990

The University of Tennessee, Knoxville, Bicentennial Committee will be commemorating the 200th anniversary of the establishment of the federal judiciary in 1990 as part of its continuing commemoration of the bicentennial of the U.S. Constitution.

The activities to be offered in 1990 during "Constitution Week," September 17-23 and "Constitution Month," September, include the following:

SYMPOSIUM ON THE BICENTENNIAL OF THE U.S. JUDICIARY

Monday, September 17 from 3:00 - 5:00 p.m in the Moot Court Room of the George C. Taylor Law Center. The topic to be discussed is, "Has the Supreme Court followed the Original Intent of the Framers?" Specific issues to be addressed are the death penalty, the right to privacy, and symbolic free speech. Participants include Law Professor Neil Cohen; Ronald Ledbetter, UT Associate General Counsel; Political Science Professor John Scheb: Law Professor Glenn Reynolds; Douglas Dutton, attorney with the Knoxville firm of Hodges, Doughty & Carson; and Communications Professor Dorothy Bowles. The program will be moderated by the Honorable Robert Murrian, Magistrate for the U.S. District Court for the Eastern District of Tennessee. UT Chancellor John Quinn will welcome the participants and make the opening remarks. A general discussion will follow the participants' presentations. An open reception will be held for participants and those attending at the Faculty Club immediately following the symposium.

- *September 25 at 7:00 p.m. "The Constitution and the Courts" (A panel discussion including Judge Robert Bork, Judge Patricia Wald, Justice Shirley Abrahamson, and University of California\Irvine Chancellor Jack Peltason. The program is moderated by Sander Vanocur.)

Each presentation is free of charge and will be followed by a live discussion. Refreshments will be served.
