The finished draft was presented to the Tennessee Supreme Court and its Committees on Criminal and Civil Procedure. ### VOICES FROM THE CLINIC

Now in its 43rd year of consecutive operation, The University of Tennessee Legal Clinic serves the dual mission of providing students with experience in law practice and professional responsibility while serving important community needs. Throughout its history, the Legal Clinic has represented thousands of low income persons in Knox County and beyond, aggressively asserting the legal rights of the poor and powerless. This year, Clinic students will represent persons accused of crimes, both felonies and misdemeanors; persons who are being evicted or living in unsafe and unsanitary housing; and, in a new Community Resource Clinic, nonprofit organizations concerned with the needs of the homeless, with issues of health care, and other pressing community problems. Why do we feel that this work is educationally important for all law students?

First, the advocacy skills that students learn in the Clinic can be generalized to any type of law practice, both litigation and non-litigation. Second, the critical, systemic analysis of the legal system that inevitably emerges from Clinic practice serves as a real-life counter to portraits of the legal system that often are painted in law school textbooks and materials. Third, issues of professional

responsibility infuse practically everything we do in the Clinic. Investing third-year students with the responsibilities of practitioners opens up new perspectives on the law school experience and introduces students to the practical realities of decisions made by attorneys. Fourth, students in the Clinic will work collaboratively on projects that affect real people and produce real results. This unique experience, which mirrors much of professional practice, often becomes the sole opportunity for students to examine such issues as working arrangements, issues of learning, stress, passion, hierarchy, race, gender, etc.. Finally, learning, working, and practicing in the Legal Clinic gives everyone a meaningful sense of the public values of lawyering.

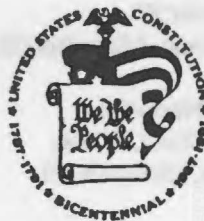
