

The UT Legal Clinic: A Retrospective from Practice by J.G. "Jack" Mitchell III

Participating in the Legal Clinic is unlike any other class you can take while in law school. It is your only opportunity to apply the knowledge you have acquired in law school with real life situations while maintaining a classroom atmosphere.

As students proceed through law school and clerk during the summer, attitudes and priorities begin to shift. Passing the bar and getting a job with a top firm drives many law students through their final two years of school. Taking every class which might be found on the bar exam is of utmost importance. In my opinion, however, they are missing out on a great opportunity and a powerful learning experience if they avoid taking a class in the Legal Clinic.

The Legal Clinic allows a student to actually practice law, either civil or criminal, without the risks associated with a private practice. This is because each student is carefully monitored by a member of the faculty who is the attorney of record for the cases upon which you work. You are able to counsel clients, take depositions, file complaints, and take part in court hearings while teachers coach and critique your work.

In addition, the Clinic's clientele is composed solely of indigents within Knox County and the services are provided free of cost to the client. Think of it, a chance to use your skills to the benefit of the community without even having a diploma, much less a license to practice. And while helping others, you help yourself.

I can assure you that you will get no greater satisfaction out of law school than you will in coming to the aid of

someone who has nowhere else to turn. My first case in Criminal Clinic involved a man who had been in jail for almost two months because he was unable to pay his court costs in a public drunkenness case. It wasn't that he would not pay, he simply did not have the money. I researched the matter and filed a motion (under the watchful eye of Professor Anderson, of course) which was granted without a hearing. You cannot get from a Contracts or Evidence class the sense of satisfaction I felt when I took this man home to his wife and kids.

The clinic also provides invaluable experience to those who are long on knowledge and short on know-how. Not only do you learn how to prepare and work a case from its inception, but you will learn to find the courthouse and the clerks' offices without assistance. You would be amazed how difficult this is for some practicing attorneys. The faculty advisors provide insight on how to deal with court clerks and other attorneys, and the staff at the Clinic won't hesitate to show you how a law office runs and how to cut through the red tape to get things done both quickly and correctly.

To merely say that I am a fan of the Legal Clinic is insufficient. The things I learned there about the practice of law go beyond the textbooks. In my private practice I often take pro bono cases similar to those I had in Clinic. I do this not because I have to, but because of the satisfaction I get from being able to not only tell those who question a lawyer's intentions that I am not in this profession just for the money, but to show them.


