# Law College Scholarship Funds

The Winter issue of the U-T Lawyer contained a list of scholarships available in the College of Law and the names of the recipients for the year 1963-1964. In view of the inquiries subsequently received, it is believed that a resume of these scholarships would be helpful.

Our scholarships, according to the manner of establishment, fall into three categories: endowed, annual, alumni and university. They are awarded on the basis of scholarship, character, and financial need.

To endow a funded scholarship requires a capital gift of approximately \$6000 if the investment income is to meet the \$225 University maintenance fee for Tennessee residents for an academic year. There are four of these funded scholarships: the John W. Green, the Arthur B. Hyman, the George C. Taylor, and the Charles A. and Myrtle Warner Scholarships.

The late John W. Green of the Knoxville Bar established three law scholarships which are awarded in recognition of unusual ability and interest in the development and advancement of the ethical standards of the legal profession. One scholarship is available to beginning students and one each to the second and third year students. Currently each scholarship is valued at \$2,000, the amount varying with income from capital investments.

Mrs. Florence S. Hyman, of New York City, bequeathed \$5,000 to the University of Tennessee to establish the Arthur B. Hyman scholarship to be awarded annually to a law student or to a student entering the College of Law. Each Hyman Scholarship amounts to \$200.

A fund established in memory of the late Honorable George C. Taylor, Judge, United States District Court, Eastern Division of Tennessee provides a scholarship annually to a law student or to a beginning law student who is a citizen of Tennessee. The current value of this scholarship is \$200.

The Charles A. and Myrtle Warner Memorial Scholarship Fund provides an annual scholarship to be awarded to a law student on the basis of scholarship, character and financial need. The current value of the award is \$225.

The Annual Scholarships are those for which there is no capital investment, the total amount of the scholarship being paid each year by the donor to The University of Tennessee. The Annual Scholarships currently available are:

The Glenn W. Woodlee Annual \$1000 Scholarship Fund has been established by The Honorable Glenn W. Woodlee, Chancellor of the 12th Chancery Division of Tennessee. Judge Woodlee is an alumnus of the College of Law. The several awards are made each year from this \$1000 annual gift to law students in amounts at least equal to the full residence fees for the academic year.

The John R. and Virginia Akans Stivers Annual \$1000 Scholarship Fund has been established by Mr. John R. Stivers and his wife, Virginia Akans Stivers, members of the Memphis Bar and alumni of the College of Law. Awards are made annually to law students or to students entering the College of Law in amounts at least equal to the full residence fees for an academic year.

H. Keith Harbor of the Chattanooga Bar, an alumnus of the College of Law, has established an Annual \$750 Scholarship. This scholarship is to be awarded to a student of outstanding ability who lacks the necessary financial resources to undertake or to complete law school work.

Arthur B. Hyman, of the New York City Bar, an alumnus of the College of Law, has established an Annual \$200 Scholarship to be awarded to a law student or to a student entering the College of Law. The award is made on the basis of scholarship, character and financial need.

The Ben H. Testerman, J., Annual \$200 Memorial Scholarship, has been established by the Real Estate Insurance Company of Knoxville, Tennessee. It is awarded to a worthy law student or to a student entering the College of Law.

The Taylor H. Cox Memorial Scholarship has been established in memory of Judge Taylor H. Cox, of the Knoxville Bar, by members of the law firm, Poore, Cox, Baker & McAuley. Judge Cox was an alumnus of the College of Law. The scholarship is in the amount of \$225 and is awarded on the basis of scholarship, character and need.

The Syllus E. Hodges Memorial Scholarship Fund was established by gift from Mrs. Irene Hays Hodges and provides for an award of \$250 annually to a third year student on the basis of character, scholarship, and interest in participating in the Legal Clinic program.

The Women's Auxiliary of the Knoxville Bar Association has established an annual scholarship of \$250 to be awarded to a senior student on the basis of character, scholarship, financial need, and interest in participating in the Legal Aid Clinic program.

The Herbert L. Davis Memorial Trust Fund offers each year an award of \$100 to the law student who has the highest scholastic average on his first two years of work in the College of Law.

The Michael F. Foley Memorial Scholarship and the James D. Hoskins Memorial Scholarship in Real Property have been respectively established by the Kansas City Title Insurance Company, Kansas City, Missouri, and the East Tennessee Title Insurance Company, Inc., of Knoxville, Tennessee. Myron Ely and Nelson Venable, alumni of the College of Law and members of the Knoxville Bar, were instrumental in setting up these scholarships. Each scholarship carries an annual award of \$225 to members of the second year class on the basis of character, scholarship, financial need and outstanding interest in the field of real property law.

The Annual Giving Program of the Development Office of the University of Tennessee makes it possible for any alumnus to contribute to the scholarship fund, in any amount desired. Any person desiring to make a gift to the College of Law Scholarship Fund should indicate his desire on the face of his check. Space does not permit the listing of the names of each contributor to the Annual Giving Program in this publication, but we do gratefully acknowledge the receipt of \$300 from C. Frank Fourmy, Memphis; \$500 from Frantz, McConnell & Seymour, Knoxville; and \$250 from Egerton, McAfee, Armistead & Davis, Knoxville, as contributions made in 1963-1964.

The money received from The Annual Giving Program is placed in a College of Law Alumni Scholarship Fund and scholarships are awarded from this fund in amounts that vary from \$200-\$400 for an academic year.

At least five University of Tennessee Scholarships are available annually to entering freshmen at the College of Law. These scholarships are currently \$250 each. They are limited to residents of Tennessee who have attended a college in Tennessee. The awards are made on the basis of scholarship, character and need.

The competition for outstanding students who are ready to enter law school is very keen because every law school is seeking gifted students to spearhead its programs and to stimulate the student body to a continuing interest in professional activities. The Unviersity of Tennessee College of Law needs its share of these students and we can only get our share through scholarships.

#### D. C. Alumni Fete Dean Warner

The Law College Alumni in the nation's capital held a reception in May honoring Dean Harold C. Warner. Dean Warner, accompanied by Professor Noel, was in Washington attending a meeting of the American Law Institute.

The reception was held at the home of Major Zane ('52) and Rosemary ('54) Finkelstein and was attended by Senator Walters and by a large number of alumni and their wives now living in the District of Columbia. Most of these alumni are engaged in legal work for the armed services, or for civilian agencies, and may have reached positions of considerable responsibility. There was much animated talk about former days at the Law College, and Dean Warner found everyone greatly interested in recent developments at the College. The hospitality was generous, and the occasion will be remembered as a most enjoyable reunion with this outstanding alumni group.
