GCT welcomes Class of '97, 159 strong

One hundred fifty-nine first-year law students have registered for the fall semester 1994. They will collectively be known as the Class of '97.

After fours days of introductory classes, they will begin their legal journey Monday, Aug. 29.

The Class of '97 hails from 17 states and the District of Columbia. In addition to Tennessee, states represented are Alabama, California, Florida, Georgia, Illinois, Indiana, Kentucky, Louisiana, Massachusetts., Michigan, Mississippi, North Carolina, Nebraska, New York, Texas, and Virginia.

The first-year students come to us from 80 colleges and universities.
Tennessee schools represented include Austin Peay, Belmont, David Lipscomb, ETSU, Freed-Hardeman, Lambuth, Memphis State (or is it the University of Memphis?), MTSU, Rhodes, Tennessee State, Tennessee Tech, Tusculum, Union, University of the South, UT-Chattanooga, UT-Knoxville, and Vanderbilt.

Forty-seven undergraduate fields of study are represented, including biblical studies, chemical engineering, creative writing, film, music composition, nutrition, Russian, and telecommunications.

3-year journey begins

The first step on the road to a new College of Law building will take place at 2:30 p.m. Saturday, Sept. 17, on the lawn adjacent to the George C. Taylor Law Center.

At that time, the groundbreaking ceremony for the \$19 million addition to GCT and renovation of the existing building will be held. All faculty, staff and students are invited to join the celebration.

Over the next three years, a new structure will be erected across the west end of GCT. The new facility will house class-rooms, the Law Library, the Legal Clinic, and faculty and staff offices. At the same time, the original GCT building, completed in the early 1950s, will be refurbished.

If things go according to plan, the UT law family will be reunited sometime in 1997 -- hopefully before the Class of '97 receives its degrees.

The move is underway

In early August, 14 faculty and two staff members moved from the Taylor Law Center to Dunford Hall. That block-and-a-half trek marked the beginning of the move away from GCT so that construction can begin on the new addition and renovation of the existing building.

The good news is that the remaining faculty and staff in GCT will remain in place until at least the late spring of '95. The student message center, student lockers, and offices of student organizations will also remain in GCT throughout the 1994-95 academic year.

The bad news, however, is that Staff Lot 12 at GCT will be closed about Sept. 2 so that construction can begin. The University is opening two new Staff 12 lots on the north side of Clinch Avenue a block north of GCT — one is between 14th and 15th streets and the other between 15th and 16th.

Law school classes have been scheduled in several different buildings across campus, and Mary Jo Hoover, associate dean for students affairs, is asking students to report any difficulties they have to her office. She is located in room 102 of GCT.

Dean Hoover also reports her

office is exploring the possibility of providing E-mail access for students during and after the evacuation of GCT. "Exploring" is the key word. "We will try, but we are making no promises," Hoover said.
