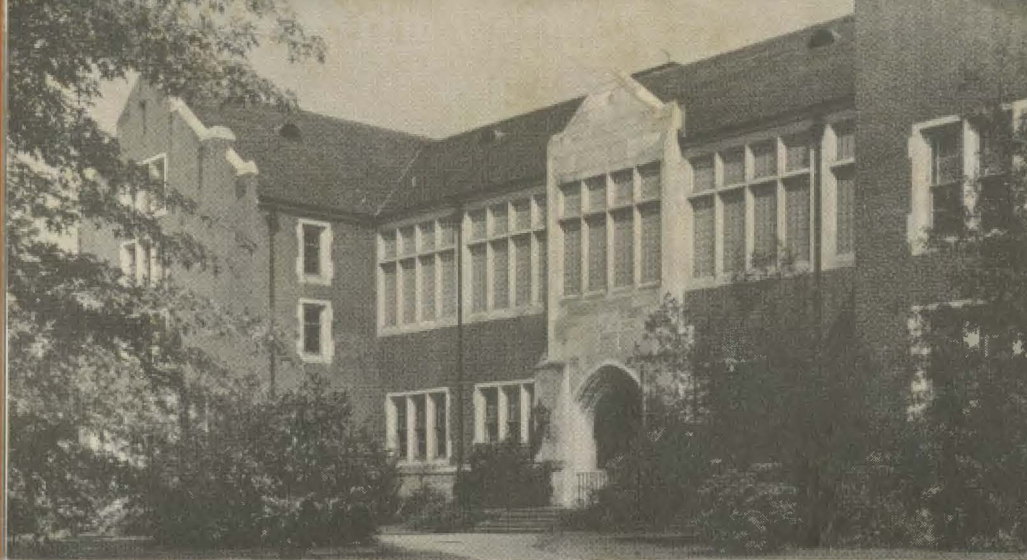

Law Day to Honor Chancellor Woodlee

The induction of the Honorable Glenn W. Woodlee, Chancellor of the Twelfth Chancery Division, Dayton, Tennessee, as an honorary member of the Order of the Coif will be the highlight of the 1967 Law Day program at the College of Law on Saturday, April 29.

The College of Law, along with the Knoxville Bar Association, again will sponsor Law Day as a homecoming event for law alumni and a time for the dissemination of knowledge about the legal profession and the law school.

During the afternoon, the finals of the Law Day Appellate Arguments will be presented. In this event four top students of the law college will compete in oral arguments before a three-judge panel. Also, during the afternoon program, awards will be presented to winners of various other competitions conducted in the law college during the year.

The annual Law Day banquet, this year honoring Chancellor Woodlee, will be held at the Senators Club on Alcoa Highway, beginning at 7:00 p.m. A social hour will precede the banquet, beginning at 6:00 p.m. Following Chancellor Woodlee's initiation into the Order of the Coif and his address of the evening on the topic of court reform, dancing will complete the day's festivities.

Chancellor Woodlee, to be honored this year, received his law degree from the U-T College of Law in 1931, and practiced in Dayton, Tennessee, until appointed to the bench in 1949. He has shown active interest in affairs of his alma mater, serving as president of the Alumni Association. A member of the Rhea County, Tennessee, and American Bar Associations, the chancellor has also served as president of the Judicial Conference of Tennessee.

He is a member of Phi Alpha Delta law fraternity, First Baptist Church of Dayton, and is a Mason and a Shriner. He is a Trustee of Bryan College, Carson-Newman College, and the East Tennessee Baptist Hospital.

Harry W. Laughlin Advises Future Members of the Bar

"I imagine every young lawyer wants to be a successful lawyer," Harry W. Laughlin told members and guests of

Roosevelt Inn of Phi Delta Phi law fraternity on February 17. The occasion was Phi Delta Phi's annual banquet at the Senators Club, and the Memphis attorney had just been initiated as an honorary member of the national law fraternity.

Presenting seven pointers designed to help the young lawyer just beginning to practice, Mr. Laughlin said:

"First: You must make up your mind to work—be industrious, nothing pays off better than this.

"Second: Be ethical and honest and do unto your fellow lawyer as you would have him do unto you. No unethical lawyer ever succeeds, for he will always be found out and will be avoided by his fellow lawyers. Every ambulance chaser I have ever known fell by the wayside. Earn the reputation that your word is your bond.

"Third: Get to know and make friends with all the lawyers in the locality where you put out your shingle. The other lawyers are the people who judge you as to ability and character when called upon to do so by prospective clients and by law directories that publish ratings as to your ability and character. Be active in your bar association, both local and state, attend all functions, serve on committees and do the job well.

"Fourth: Many of you will be associated with law firms. Serve the older lawyers well. When you are called upon to research a question of law, to file a pleading, or the like, be sure to act promptly and appear willing to work. You have to sell yourself, make the members of the firm like you, need you and become dependent on you. That's the way to become a partner in the firm.

"Fifth: Have some connections with civic projects, but don't become too active in too many of them. As an older lawyer once told me, a lawyer too active in civic affairs will cause his clients or prospective clients to wonder when he will have time to represent them.

"Sixth: Always be prepared when you appear in court. On these occasions you are in the public eye; the judge, other lawyers and laymen observe you. At that time your ability is being judged. Some lawyers think the judge should know all the law. This, of course, is not true. The lawyer is supposed to present not only the facts, but also the law to the court so that the judge can decide the case. You would be surprised how many lawyers seem to forget this.

"Seventh: Always be respectful to the court. Again, your demeanor in the courtroom affects your reputation as a lawyer. A dignified court causes the laymen to appreciate the law and respect it."
