An additional financial resource is now available to University of Tennessee law students through Law Plan, a consolidated student loan program developed by the Law School Admission Council/Law School Admissions Services to meet the increasing costs of legal education.

By utilizing Law Plan, a student may have access through one application to three separate loan programs - the Guaranteed Student Loan (GSL), the Auxiliary Loan to Assist Students (ALAS), and the Law Access Loan (LAL) The loan program is available to any student enrolled in or admitted for enrollment in any LSAC member school (all ABA-accredited schools). No bank/customer relationship, state residency, nor cosigner is required. The LSAC/LSAS promises prompt processing of all applications

Changes in university Financial Aid office policies now make it possible for UT students to take advantage of the Law Plan, which may allow students on a need basis to borrow amounts in excess of the limits set for disbursement of university-based aid.
