The Student Division of the National and Tennessee Association of Criminal Defense Lawyers will present Van Martin on Monday, February 7, at noon in the Moot Court Room. Mr. Martin will speak on "Ethics, Morality, Integrity: Can you be an honest lawyer?" Mr. Martin is a local practitioner.



The 1994 Charles Henderson Miller Lecture in Professional Responsibility will be Monday, February 14, at noon in the Moot Court Room. Professor of Law Sylvia Ann Law from New York University School of Law will present "A Right to Health Care That Cannot Be Taken Away: Reflections on Twenty Years of Health Care Advocacy." The lecture series was established in 1977 in honor of Professor Charles H. Miller, the founding director of The University of Tennessee College of Law Legal Clinic.

Professor Law teaches constitutional law, family law, federal courts, health law, torts, and welfare law at NYU. She is also NYU's director of the Arthur Garfield Hays Civil Liberties Memorial Program.

After earning a B.A. in 1964 from Antioch College, Professor Law received a J.D. in 1968 from New York University. After graduation from law school, she was the Reginald Heber Smith Community Lawyer at the Columbia Center on Social Welfare Policy and Law. From 1969-70 she was a lecturer at the London School of Economy and Political Science. Prior to joining the New York University faculty in 1973, she served as the staff director for the Pennsylvania Health Law Project. She has been a full tenured professor at NYU since 1979.

Her book, *Blue Cross: What Went Wrong* (2nd ed., 1974) received a New York Times Outstanding Book Award. Professor Law has co-authored two other books: *Political and Civil Rights* (with T. Emerson, Haber, Dorsen and Chachkin, Volume 2, 1978) and *American Health Law* (with Annas, Rosenblatt and Wing, 1990). She has had numerous articles published in various law reviews.

Professor Law is a member of the New York and Pennsylvania Bars, the American Civil Liberties Union, the Society of American Law Teachers, the National Lawyer's Guild, the Alan Guttmacher Institute, and the Non-Traditional Employment for Women Council.

#### **VOICES FROM THE LEGAL CLINIC**

### College of Law Houses Largest Firm in Knoxville

This semester the UT Legal Clinic is the largest law firm located in Knoxville (excluding government agencies like TVA). The 45 members (5 faculty and 40 student attorneys) of the firm will serve over 150 clients during the next few months, handling both civil and criminal matters.

The firm has two major departments - - civil and criminal. Attorneys in the criminal department handle felony and misdemeanor matters in General Sessions and Circuit Court in both Knox and Loudon Counties. The attorneys master the basics of investig-ation, handling a preliminary hearing, participating in plea negotiations, and trying a case. Jerry Black and Gary Anderson are the senior attorneys in the criminal department.

The civil department is divided into three practice groups - - housing, employment, and homeless advocacy.

•••• The housing practice group, headed by Dean Rivkin, represents clients facing eviction or living in substandard housing in both judicial and administrative fora. The housing attorneys also engage in extensive negotiations with landlord representatives and attorneys.

•••• Phyliss Wimberly and Pam Wolf (MSW) lead the homeless group. Attorneys in the group interview potential clients at local homeless shelters, handling public benefits, housing, mental health, and other matters in court and before administrative agencies. In addition the attorneys present workshops on legal issues to groups of homeless persons.

•••• In the employment practice group, attorneys handle unemployment compensation claims primarily. The attorneys investigate the case, conduct contested evidentiary hearings before an administrative law judge, and handle any Legal Clinic continued.

necessary appeals. Students also may have an opportunity to be involved in employment discrimination litigation in either federal or state court. Doug Blaze is the senior attorney.

Although the law firm is fully staffed at the present time, later this spring the firm will accept applications for 40 new openings in the fall semester. If you have any questions contact one of the senior attorneys.

#### Transition and the Future

The Law Library is planning for the "transition phase" when construction of the addition to, and renovation of, the College of Law begins. During the transition the Law Library will be housed entirely in the Annex or White Avenue Building. To make this process as painless as possible we will be issuing periodic notices about changes in library policies and procedures and availability of materials.

Over the next several months you will notice that materials are "disappearing" or being moved within the existing facility. This is being done to create additional space for new staff and functions within the Law Library and to streamline the collection for placement during the transition phase.

Since the space for library materials will be reduced during this time, certain parts of the collection will be placed in storage until the new building is completed. During this first phase materials to be placed in storage will be limited to duplicate copies. During the Holiday Break duplicate copies of the *Federal Reporter 2nd Series* and *Federal Supplement*, which were located in the Lower Reading Room, were boxed and put into remote storage. All materials were inventoried and will be available for retrieval should existing copies be missing. The location of some sets within the Lower Reading Room has changed, notably the *Code of Federal Regulations* (CFR), the *Federal Register*, and the Shepard's and indexes for CFR. Please ask a library staff member for assistance in locating these titles.

Space has also been created across from the Circulation Desk for our new Reference Librarian. Kelly Browne, a recent graduate of the University of Washington Law Librarianship program, joined the staff January 11. She graduated from the University of Cincinnati Law School and practiced law in the Seattle area for three years before completing her library degree. Her duties include providing reference assistance, library instruction, coordinating Computer Assisted Legal research training, developing library and research guides, and preparing bibliographies. Please stop by and welcome Kelly to the College of Law.

Every effort will be made to minimize the impact of the building process on the Law Library users. Please bear with us as we continue to prepare for an exciting future for the College and the Law Library.




