

... in nuclear waste disposal choices.

Dixie Lee Ray, former Governor of Washington state and former Chairperson of the Atomic Energy Commission (forerunner of the U.S. Department of Energy), will be the keynote speaker at the banquet on Thursday, March 13. Other speakers and panelists for the two-day event include Dr. Jeffrey Schevitz of the Department of Applied Systems Analysis in West Germany, A.H. Schilling, Counsel for Battelle Human Affairs Research in Washington, D.C., Susan Wiltshire of Massachusetts who serves on the Board of Radioactive Waste Management of the National Academy of Sciences, Steve Frishman, Director of Nuclear Waste Programs for the Office of the Governor of Texas, and Gary Davis, Counsel for the Legal Environmental Assistance Foundation, plus many other leaders in the field.

Thursday's presentations and workshops will focus on monitored retrievable storage (MRS), while the emphasis on Friday will be on repository siting. There will be a \$30 charge for the meal functions.

A special symposium issue of the <u>Tennessee Law Review</u> will be published from papers prepared by the Colloquium's faculty.


