

She has her undergraduate degree from Radcliffe College. Ms. Ansley practiced for eight years in Knoxville, concentrating in representing plaintiffs in personal injury litigation. Professor Ansley will teach Gratuitous Transfers (the new course that combines the coverage of Decedents' Estate and Future Interests) this Fall, and in the Spring, she will teach Property (the new

HOWARD BRILL

VISITING PROFESSOR OF LAW (FALL. 1988) - Professor Brill is a Professor of Law at the University of Arkansas in Fayetteville. He holds a J.D. degree from the University of Florida, where he was Editor in Chief of the Law Review and was elected to the Order of the Coif. His undergraduate degree is from Duke, and he also holds an L.L.M. from the University of Illinois. Professor Brill has been teaching for 14 years, concentrating his work in the areas of civil procedure, professional responsibility, and remedies. He comes to us with a reputation as an outstanding classroom teacher, and he has often received the outstanding professor award at Arkansas. He will teach Civil Procedure I and Family Law in the Fall.

JOHN A. WALKER

ADJUNCT ASSOCIATE PROFESSOR OF LAW - Mr. Walker, who is one of the leading commercial law practitioners in Knoxville and in Tennessee, will teach Bills and Notes in the Fall. He holds an undergraduate degree from Duke and his J.D. from Columbia University, where he was Editor in Chief of the Columbia Journal of Transnational Law.
