A RIGHT TO BEAR ARMS? MOOT COURT DEBATE PLANNED THIS FALL

On Wednesday, October 29, the Knoxville-Knox County Constitution Bicentennial Commission, the University of Tennessee College of Law, and the SBA will sponsor a Moot Court program on the subject of the right to bear arms. Law students will argue the constitutional issues in an appellate argument format, then the presiding judge will open the discussion to the audience and elicit reactions and comments.

The basis for the argument will be the adoption of a fictitious city ordinance prohibiting the possession of all firearms above a certain caliber and the arrest of a citizen for violating the ordinance.

This moot court "debate" will be held in the Moot Court Room from 11:00 a.m. to 12:00 noon. The public will be invited and encouraged to participate.
