Knoxville Chapter of Inns of Court Chartered

The Inns are community-based organizations of members of the legal profession dedicated to promoting continuing improvement of the skills, ethics, and professionalism of trial and appellate advocates in an atmosphere of collegiality patterned loosely after the venerable English Inns of Court. The initial interest in a pilot Inn was first expressed by Chief Justice Warren E. Burger in 1979 and was organized in 1980 in Provo, Utah, in affiliation with the J. Reuben Clark Law School at Brigham Young University. At the present time, there are about 42 chartered Inns. Each Inn is composed of a cross-section of the legal community and may include up to 65 judges, lawyers, law teachers, and law students. Twelve of our third-year law students will also be selected this fall to participate in the organization.

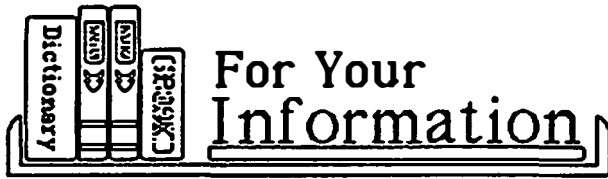

Community/College Forum on Federal-State Relations

The UT Constitution Bicentennial Committee has received a grant from the national Commission on the Bicentennial of the U.S. Constitution to conduct a forum that will engage members of the faculty and the community in a discussion of a constitutional issue that is relevant to the ratification controversy over the Constitution that took place 200 years ago.

The topic chosen is **"Federalism: Original Intent and Current Reality."** The Knoxville Bar Association is a cooperating sponsor. The forum will take place on the morning of **November 12, 1988**, at the Holiday Inn/World's Fair. Morning presentations will be by faculty members, local attorneys, and representatives of the press. A luncheon by Walter Lambert, Associate Vice President for Federal Affairs of the University of Tennessee, will conclude the forum.

(1) The National Association of College & University Attorneys' present a **NATIONAL LEGAL WRITING COMPETITION** for the best law student article on a topic relating to legal issues in higher education. The Donald L. Reidhaar Prize of \$1 000 and publication in **The Journal of College and University Law** go to the winner. Deadline: June 16, 1989.

(2) The United States Trademark Association presents the **Stephen P. Ladas Award** for the best article on trademarks. A cash prize of \$1 000 along with a 3-volume set of **Patents, Trademarks and Related Rights-National-Inter-national Protection** will be awarded to the winner. Deadline: papers may be submitted throughout the year.

(3) The SoloSource Incorporated presents the **First Annual Chairman's Scholarship Fund** for second- and third-year law students interested in Family Law. A \$500 scholarship will be awarded to the winner of the research and writing competition. Deadline: December 1, 1988.

(4) The National Energy Law and Policy Institute of The University of Tulsa's College of Law presents an **Energy Law Essay**
