PAT HARDIN APPOINTED ASSOCIATE DEAN; MARY JO HOOVER EXTENDS LEAVE OF ABSENCE

Professor Pat Hardin has accepted a half-time appointment as Associate Dean for Academic Affairs and Administration. He will assume many of the responsibilities formerly held by the newly-appointed Acting Dean, John Sebert. Pat will also be in charge of many of the duties normally undertaken by Associate Dean Mary Jo Hoover, who has extended her leave for the 1986-87 academic year to help develop a new computerized student information system for UT.

Associate Dean Pat Hardin's duties will include student academic counseling and advising, curriculum planning, faculty affairs, chairing the building committee, and assisting with budget preparation and allocation. He will also teach one course each term.

Associate Dean Julie Hardin will continue to oversee alumni affairs and development, public relations, and the activities of the Public Law Institute. In addition, she will work with the various student organizations, coordinate Law Week and year-end academic and service recognition activities, and supervise the production of the Law College bulletin.

Assistant Dean Doug Wells will be responsible for the admissions program, financial aid, transfer evaluations, and coordination of the tutorial program. He will also share with Dean Pat Hardin some of

the student academic affairs and advising duties, as well as undertake other responsibilities of general administration. Dean Wells has also been selected to be an administrative intern with the Chancellor's office this year. Congratulations, Doug!

FOR YOUR HEALTH AND INFORMATION!

University health services are available to any student who has paid the full activities fee for nine (9) or more credit hours. Law students who are taking fewer than nine (9) credit hours may also pay the separate health fee of \$26 per term to receive the benefit of these health services. This health fee may be paid at any time during the term.

Student group health insurance is also available to law students through Health Services, 1818 Andy Holt Avenue. If purchased at the beginning of the fall term, the cost is \$112 for a full academic year. For spring and summer terms only, the cost is \$69. For the summer term only, the cost is \$28.

ACADEMIC SUPPORT PROGRAM CONTINUES

Under long-standing policies approved by the faculty, an academic support program involving small group tutorials will again be offered this year to some first year students. Each semester, tutorials will be offered in three subjects: in the fall - Civil Procedure I, Contracts I, and Torts I;

and Contracts II, Property I, and one other course in the spring. For the fall semester, participation in the tutorial is limited to 10% of the entering class. Fall participants are selected by the Tutorial Coordinator (Dean Wells) and the Associate Dean for Academic Affairs (Dean Pat Hardin) based upon admissions material indicating that the student might benefit from such a tutorial. In the spring semester, any first year student whose first semester GPA is below 2.0 is eligible to participate in the program.

MOOT COURT DEBATE PLANNED THIS FALL

On Wednesday, October 29, the Knoxville-Knox County Constitution Bicentennial Commission, the University of Tennessee College of Law, and the SBA will sponsor a Moot Court program on the subject of the right to bear arms. Law students will argue the constitutional issues in an appellate argument format, then the presiding judge will open the discussion to the audience and elicit reactions and comments.

The basis for the argument will be the adoption of a fictitious city ordinance prohibiting the possession of all firearms above a certain caliber and the arrest of a citizen for violating the ordinance.

This moot court "debate" will be held in the Moot Court Room from 11:00 a.m. to 12:00 noon. The public will be invited and encouraged to participate.

What's New

During the past year several new research tools have been added to the Law Library resources which will enhance the research capabilities of library users. Early last fall LEXIS, a full-text computerized legal retrieval system, was installed to complement our subscription to WESTLAW, thereby giving library users access to both automated systems. After participating in computer-assisted legal research training sessions, students will be able to decrease research time on such things as "Shepardizing" or tracking the procedural history of a case. Another new research feature is LEGALTRAC, a laser disc based legal periodical indexing and retrieval system. The system was installed this past spring on a trial basis and a decision was made to subscribe to the service on a permanent basis. LEGALTRAC provides the user with subject, author, and title access to articles published in approximately 750 legal journals and newspapers from 1980 to the present. Although these services are very expensive to the Law



Library, they are provided free of charge to students and faculty for purposes of doing academic research.

Library Policy

Another newsworthy item regarding the Law Library is the revision of the food, drink, and tobacco product policy within the library. After repeated, but fruitless efforts to encourage compliance with a less stringent policy, it has been deemed necessary to establish a policy whereby NO food, drink, or tobacco products will be allowed in any part of the Law Library. It is regretful that such a policy has become necessary, but persistent violations of the previous policy caused undue damage to library materials and equipment. In addition to damage done to furniture and carpeting, a number of book materials and some computer components have required replacement as a result of the careless use of food and drink. The blanket policy will be easier to enforce than the previous "compromise" policy. Persistent violators will be referred to the Associate Dean for Academic Affairs and Administration. Failure to comply with this policy may also result in disciplinary action in accordance with the regulations set forth in the University-wide Hilltopics.
