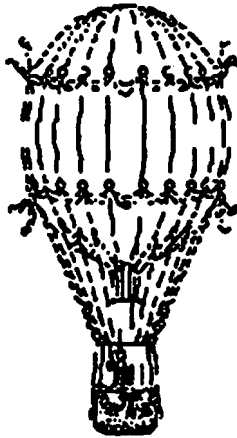

Freezes water with a single glance.

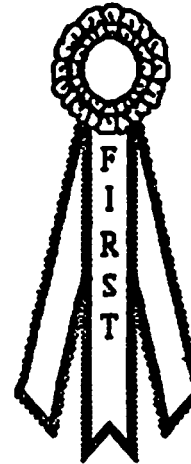

PAPERS SOLICITED FOR NATURAL RESOURCES LAW SYMPOSIUM

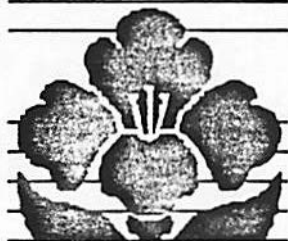

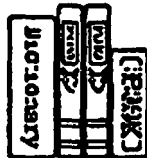
