




THE COLLEGE OF LAW PROVIDES AFTER-HOURS MESSAGE SERVICE

TAYLOR TRIVIA: In what year was the first Hooding ceremony held? Answer to last month's Taylor Trivia: The University of Tennessee College of Law's Legal Clinic was established in 1947. It was the first American clinic with its own offices built in the school. Professor Charles Miller was the director. A major element of the College's public service program is the Legal Clinic.



UT COMPUTERS NOW AVAILABLE! In the College of Law: Seven (7) IBM PCs and PS/2s are currently available in the Computer Lab, Room A-401, on the 4th floor of the law library. Law Library Director Bill Beintema will provide computer instruction/assistance every Tuesday and Friday from 3:00 to 4:00 p.m. beginning September 8. (Four (4) additional PCs will be available in a few weeks.) Computer use is free on deposit of UT ID at the circulation desk where micros may also be reserved. The software in use is WordPerfect (word processing) and CALI materials (computer- assisted legal instruction exercises on many subjects.). Students may use their own software on either 5.25 or 3.5 inch diskettes. Dot matrix printers with tractor feed paper are also provided. Outside the College of Law: SCALE in Room 248 of the University Center has computers for students' use and also provides short courses on the use of computers for word processing. SCALE provides Macintosh instruction for \$5 and IBM PC instruction for \$15. Call 974-1078 to schedule training. The computer use is free; printing is 5 cents a page.


