# Memorial: William J. (Bill) Beintema (1944-2015)\*

¶1 After many years as a law librarian, law library director, and humanitarian, Bill Beintema passed away on November 12, 2015, in Knoxville, Tennessee. Bill was born and grew up on Long Island, New York, in the town of Sayville. He earned both his undergraduate and Juris Doctor degrees from the University of Miami. He obtained his Master of Library Science degree at Florida State University. He is survived by his wife of forty-two years, Jane, who often accompanied Bill to regional and national professional meetings.

¶2 Bill started his career as the assistant director at the University of Miami School of Law Library. He accepted his first director position in 1978 at the Oklahoma City University Law Library, where he served for six years and cofounded the Central Oklahoma Law Librarians Association. In 1984, he became the director of the Law Library at the University of Tennessee College of Law in Knoxville. He served faithfully and effectively in that position for twenty-five years, retiring in 2009.

¶3 In addition to leading the Law Library at the University of Tennessee, Bill contributed broadly to the College of Law in various capacities, including chairing as well as serving as a member on a number of committees. In particular, he served on the College's Building Committee in the 1990s during an important time during the expansion of the building, playing a significant role in planning and overseeing the growth and renovation of the facility, including the law library. In recognition of his service to the college, he was twice awarded one of the college's highest honors, the Carden Faculty Award for Outstanding Service. While at the University of Tennessee, Bill published an annotated bibliography addressing legal issues involving clergy malpractice.

¶4 Bill also had a distinguished and meaningful record of professional service during the course of his career. He was intimately involved with the American Association of Law Libraries (AALL), chairing and serving on numerous committees and in various capacities, including the Placement Committee, Awards Committee, and Statistics Committee. He also chaired CONELL very early in his career. Bill served three years on the *Law Library Journal* editorial staff and also served for an extended period of time on the editorial board of the quarterly newsletter of the Audio Visual/Micrographics Special Interest Section. Bill took great pride in the fact that he had attended forty-five consecutive AALL Annual Conferences, often with his wife Jane by his side.

¶5 Additionally, Bill made notable contributions to the profession through the Southeastern Chapter of AALL (SEAALL), where again he served in numerous capacities. He was honored with the SEAALL Special Service to the Chapter Award in 2001, and he received a lifetime membership and appreciation award in 2011. He

was also the founding director of COSELL, the Consortium of Southeastern Law Libraries, and served a number of years as treasurer of the consortium.

¶6 Perhaps Bill's greatest contributions to the profession, however, came through the many connections he made with other law librarians throughout the profession and across the country. He has been described as warm, friendly, entertaining if not hilarious, and a good soul. He befriended many of us and was often especially supportive of those early in their careers. He had a way of making others feel important and comfortable. Those who knew him best described him as a light spirit with a big heart, a jokester with few equals in the profession. In a world filled with problems and challenges, Bill's humor and compassionate care for other people are greatly missed.—*Scott Childs*¹

¶7 Bill was my library director for more than ten years. He was a wonderful mentor and friend to me. He provided gentle guidance when I was unexpectedly promoted to acting head of public services when I was barely out of library school and had been at the Joel A. Katz Law Library for less than a year. He showed me the value of making connections and staying actively engaged in the profession, even though our library was tucked far away from major metropolitan areas and other law libraries. Most of all, Bill was one of the kindest people I have known. He loved to tease, but he never had a mean word for anyone, and I knew I could turn to him for a corny joke or a friendly chat whenever I needed a bit of warmth. Bill was a man of broad interests, from his church, to travel, to photography and all sorts of work with graphics, images, and publishing. He loved discovering new restaurants as well as cooking—his molasses icebox cookies were legendary and are sorely missed at our library gatherings! I consider myself fortunate to have worked with him as long as I did.—Sibyl Marshall²


# "When Pigs Fly"

# American Association of Law Libraries Law Library Journal Author's Guide

# **General Information for Contributors**

Law Library Journal is the official journal of the American Association of Law Libraries. It is published quarterly and circulates to nearly 4500 members and subscribers. This guide is provided to assist authors in preparing articles for the *Journal*.

1. Content. Law Library Journal includes articles in all fields of interest and concern to law librarians and others who work with legal materials. Examples include law library collections and their acquisition and organization; services to patrons and instruction in legal research; law library administration; the effects of developing technology on law libraries; law library design and construction; substantive law as it applies to libraries; and the history of law libraries and legal materials. Submissions aimed at all types of law libraries and at all areas of library operations are encouraged. The Journal also encourages the publication of memorials to deceased members of the Association.

In preparing a manuscript, an author may use any approach appropriate to the topic: case studies, descriptive or historical narratives, commentaries, or reports on research projects. Bibliographies on topics of substantive law or of law librarianship are welcomed; annotated bibliographies and bibliographic essays are preferred.

- 2. Author's Responsibilities. Manuscripts are accepted for review with the understanding that they have not been published elsewhere and are not currently being considered for publication elsewhere. Authors are responsible for the accuracy of statements in their articles and for the accuracy and adequacy of the references. Citations to published literature should be carefully checked. References to unpublished material may be included; however, the author is responsible for securing approval, in writing, from any person cited as the source of an unpublished work. The author is also responsible for obtaining permission to use copyrighted material. Such permissions should be secured in writing. By submitting a manuscript to Law Library Journal, an author is certifying that he or she has obtained all necessary approvals and permissions. Copies may be requested by the editor.
- 3. Editorial Policies. Manuscripts are evaluated for their appropriateness for *Law Library Journal*, significance, and clarity. If accepted, manuscripts will be edited for clarity of expression and to remove any ambiguities in the presentation. If extensive revisions are indicated, manuscripts are returned to authors for approval of changes and corrections before type is set. Throughout the editorial process, the editor's purpose is to assist authors in effectively communicating their ideas. The editor welcomes advance queries from authors about possible *Journal* articles.
- 4. Style Considerations. For general questions of style, follow *The Bluebook* (20th ed. 2015). Textual references and footnotes must be in accordance with *Bluebook* rule 2. For matters not covered in the *Bluebook*, use *The Chicago Manual of Style* (16th ed. 2010). For spelling, use *Merriam-Webster's Collegiate Dictionary* (11th ed. 2003), supported by *Webster's Third New International Dictionary*.
- 5. Bibliographies. All bibliographies, whether submitted independently or to accompany a substantive article, should follow the bibliography style described in paragraphs 14.56–14.317 of *The Chicago Manual of Style*. Prospective compilers

of bibliographies or authors of bibliographic essays are encouraged to contact the editor about their projects before committing them to final form.

# **Instructions for Preparing Manuscripts**

- 1. Title and Author Page. Provide a title that is brief, specific, and descriptive of the article's content. Below the title, provide the name(s), professional title(s), and affiliation(s) of the author(s), and the address of the author to whom correspondence should be sent.
  - 2. Abstract. Provide an abstract of fifty words or less.
- 3. Table of Contents. If the article is divided into headings and subheadings (which is preferred), provide a table of contents telling where in the text each heading is found.
- 4. Text. The entire text, including quotations, should be typed double-spaced with 1½ inch margins on all sides. Quotations of fewer than fifty words should be enclosed in quotation marks; quotations of fifty or more words should be blocked off and indented an additional inch on the left and right. Footnotes should be identified in the text by superscript numbers.
- 5. Footnotes. Acknowledgments (if any) should be preceded by an asterisk and placed before the first footnote. Footnotes should follow the form of *The Bluebook* (20th ed. 2015).
- 6. Appendices, Bibliographies, Tables, and Illustrations. Supplementary materials, such as appendices and bibliographies, should be provided on separate pages. Each table, illustration, and all similar material that is to be published within the text should be individually numbered (e.g., "Table 1"). Indicate the desired placement by providing an appropriate instruction within brackets in the text (e.g., [Insert Table 1]). Camera-ready copy must be supplied for all illustrations.
- 7. Submitting the Manuscript. Manuscripts should be sent to the editor, James E. Duggan, Tulane University Law School, 6329 Freret St., New Orleans, LA 70118. Telephone: (504) 865-5950; e-mail: duggan@tulane.edu. Electronic versions in either Word (preferred), WordPerfect, or PDF may be sent by e-mail. If manuscripts are submitted in paper format, two complete copies should be mailed to the address above.

The editor will notify the author that the manuscript has been received and inform the author when an acceptance decision may be expected. After an article has been accepted, the editor will require an electronic manuscript, either on disk or as an e-mail attachment.

The author (one designated author, if there are multiple authors) will receive a clean copy of the manuscript before it is sent to the printer. The copy must be proofread, approved, and returned within fifteen days. Before publication, the author will be asked to agree to the *Journal's* policy on classroom photocopying, which is published in each issue of the *Journal*. Upon publication, the author will receive two free copies of the issue in which the article appears, plus twenty-five individual offprints of the article itself. A form for ordering additional reprints will be sent to the author at the time the issue is published.
