**RESERVATION OF RIGHTS OF THE 10.75% NOTES TRUSTEE TO THE
DISCLOSURE STATEMENT FOR THE DEBTORS’ SECOND AMENDED JOINT
PLAN OF REORGANIZATION PURSUANT TO CHAPTER 11 OF THE
BANKRUPTCY CODE**

Wilmington Trust, National Association, as Successor Indenture Trustee (the “10.75% Notes Trustee”) for the 10.75% Senior Unsecured Notes (the “10.75% Notes”) issued by Caesars Entertainment Operating Company, Inc. (“CEOC,” and, together with its affiliated debtors, the “Debtors”), and guaranteed by 137 wholly-owned domestic Debtor subsidiaries of CEOC (the “Subsidiary Guarantors”) under that certain indenture dated February 1, 2008, by and through its undersigned counsel, files this reservation of rights (the “Reservation of Rights”)² to the *Disclosure Statement for the Debtors’ Second Amended Joint Plan of Reorganization Pursuant to Chapter 11 of the Bankruptcy Code* [Dkt. No. 3484] (the “Second Amended Disclosure Statement”) and represents as follows:

RESERVATION OF RIGHTS

1. The 10.75% Notes Trustee understands that the Debtors and the Debtors’ parent entity, Caesars Entertainment Corporation, have proposed a plan treatment with holders of the

10.75% Notes receiving, *inter alia*, payment of 85% of their claim. See Caesars Entertainment Operating Co. Disclose Information in Connection with Discussions with Certain Creditors and Other Parties as Part of Restructuring Process, (April 26, 2016), <http://www.prnewswire.com/news-releases/caesars-entertainment-operating-co-discloses-information-in-connection-with-discussions-with-certain-creditors-and-other-parties-as-part-of-restructuring-process-300257510.html>. The 10.75% Notes Trustee continues to work to transform that understanding into a definitive deal that would be supported by a majority of the holders of the 10.75% Notes and the 10.75% Notes Trustee. In particular, the parties are seeking to reach closure with respect to the value of consideration necessary to represent a payment of 85%. Those negotiations are ongoing, and the 10.75% Notes Trustee remains hopeful that definitive documentation will soon be finalized.

2. That said, it remains possible that these negotiations will ultimately fail to achieve a final agreement with respect to the treatment of the Subsidiary-Guaranteed Note Claims. As it stands, the Debtors' Second Amended Disclosure Statement lacks material information that would be essential for interested parties, including the holders of the 10.75% Notes, to make an informed judgment with respect to the underlying plan. Among the missing information is a liquidation analysis illustrating the amount that holders of the 10.75% Notes could recover from the substantial unencumbered assets owned by their Subsidiary Guarantors in a hypothetical chapter 7 liquidation. For all of these reasons, the 10.75% Notes Trustee hereby reserves its right to object to the Debtors' Second Amended Disclosure Statement at a future date. This reservation of rights imposes no prejudice on the Debtors, as they have yet to file a further amended plan or disclosure statement that discloses material information not included in its prior filings with the Court.
