25 **PLEASE TAKE NOTICE** that, on **March 27, 2015 at 10:00 a.m. local time**, the
26 Bankruptcy Court will conduct a hearing (the "**Sale Hearing**") to address the request by

1 SKYMALL, LLC and the other debtors and debtors-in-possession (the “**Debtors**”) in the above-
2 captioned, jointly administered Chapter 11 cases (the “**Bankruptcy Cases**”), to sell all or
3 substantially all of their assets and to assume and assign certain of their executory contracts and
4 unexpired leases pursuant to the *Motion For Orders (I) Authorizing Bidding Procedures And*
5 *Auction, (II) Scheduling Sale Hearing And Approving Notice Thereof, (III) Authorizing Sale Of*
6 *Assets, And (IV) Granting Related Relief* [Docket No. 22] (the “**Sale Motion**”), and in accordance
7 with the Bankruptcy Court’s *Order Establishing Bid Procedures for Auction Sale, Scheduling*
8 *Hearing on Sale Motion, and Granting Related Relief* [Docket No. 53] (the “**Procedures**
9 **Order**”).¹ **The Sale Hearing will be held in Courtroom 601, United States Bankruptcy**
10 **Court for the District of Arizona, 230 North First Avenue, Phoenix, Arizona,**

11 **PLEASE TAKE FURTHER NOTICE** that, among other relief, the Debtors request
12 in the Sale Motion the entry of an Order pursuant to Bankruptcy Code §365: (1) approving
13 the assumption and assignment of certain executory contracts and unexpired leases of the
14 Debtors, (2) determining that either (a) there are no defaults under such contracts and leases
15 other than the payment of certain amounts required by Bankruptcy Code §365(b)(1) proposed
16 by the Debtors, if any, or (b) any such defaults have been adequately addressed in an
17 agreement between the Debtors (and/or the Prevailing Bidder (or backup bidder)) and the
18 Counterparty to any executory contract or unexpired lease proposed to be assumed and
19 assigned by the Debtors, and (3) determining, at the Sale Hearing, that the Prevailing Bidder
20 (or backup bidder) has demonstrated adequate assurance of future performance under such
21 contracts and leases.

22 **PLEASE TAKE FURTHER NOTICE** that a schedule listing executory contracts and
23 unexpired leases of the Debtors that may potentially be assumed and assigned pursuant to the
24 Sale Motion (the “**Subject Contracts and Leases**”) is attached to this Notice as **Exhibit A**.

3 estimated amounts (the "**Cure Amount**") owing under a Subject Contract or Lease, as of April
4 15, 2015—the projected sale closing date. PARTIES RECEIVING THIS NOTICE SHOULD
5 CAREFULLY REVIEW WHETHER THEIR NAMES AND CONTRACTS OR LEASES
6 ARE LISTED ON THE ATTACHED EXHIBIT A.

7 **PLEASE TAKE FURTHER NOTICE** that, unless the Debtors and any Counterparty
8 to a Subject Contract or Lease that may be assumed and assigned pursuant to the Sale Motion
9 have reached an agreement with respect to such assumption and assignment, the Debtors will
10 request at the Sale Hearing a determination, under Bankruptcy Code §365, that payment of
11 the Cure Amount, if any, listed for each of the Subject Contracts and Leases on the attached
12 Exhibit A will cure any and all defaults thereunder as a prerequisite to the assumption and
13 assignment of those Subject Contracts and Leases that the Prevailing Bidder (or backup
14 bidder) has designated for assumption and assignment. The Debtors believe that there are no
15 amounts that need to be paid in order to cure any default under any of the Subject Contracts
16 and Leases listed on Exhibit A, other than payment of the Cure Amounts (if any) listed on
17 Exhibit A.

18 **PLEASE TAKE FURTHER NOTICE** that ANY OBJECTION TO THE
19 PROPOSED ASSUMPTION AND ASSIGNMENT OF ANY OF THE SUBJECT
20 CONTRACTS AND LEASES, INCLUDING, WITHOUT LIMITATION, ANY OBJECTION
21 TO ANY OF THE PROPOSED CURE AMOUNTS LISTED ON EXHIBIT A, MUST BE
22 FILED WITH THE BANKRUPTCY COURT AND SERVED ON THE DEBTORS'
23 COUNSEL ON OR BEFORE **MARCH 4, 2015**. Any objection must be in writing and must
24 set forth (i) the basis for the objection, (ii) with specificity, the amount the Counterparty
25 asserts as the Cure Amount, and (iii) appropriate documentation in support of the Cure

1 Amount alleged by the Counterparty. If any such objection is not resolved prior to the Sale
2 Hearing, that objection will be considered by the Bankruptcy Court at the Sale Hearing.

3 **PLEASE TAKE FURTHER NOTICE** that, any Counterparty failing to timely file an
4 objection to the Cure Amount set forth in the attached Exhibit A shall be forever barred from
5 objecting to the Cure Amount and from asserting any additional cure or other amounts against the
6 Debtors, their estates, and the Prevailing Bidder with respect to the Subject Contract or Lease to
7 which it is a Counterparty. For the avoidance of doubt, no executory contract or unexpired lease
8 will be assumed and assigned until and unless a transaction closes pursuant to the Sale Motion
9 that proposes assumption and assignment of such executory contract and/or unexpired lease.
