APPLICATION TO EMPLOY SNELL & WILMER L.L.P. AS LOCAL COUNSEL FOR THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS NUNC PRO TUNC TO FEBRUARY 6, 2015

1 Snell & Wilmer L.L.P. and the Official Committee of Unsecured Creditors (the
2 “Committee”) in the above-captioned Chapter 11 cases (the “Bankruptcy Cases”), hereby submit
3 this Application (“Application”) to retain and employ Snell & Wilmer L.L.P. (“Snell & Wilmer”)
4 as local counsel for the Committee pursuant to 11 U.S.C. § 1103(a) of the United States Code (the
5 “Bankruptcy Code”) and Rule 2014 of the Federal Rules of Bankruptcy Procedure (the
6 “Bankruptcy Rules”) nunc pro tunc from February 6, 2015. In support of this Application, the
7 Committee relies on the “Affidavit in Support of Application to Employ Snell & Wilmer L.L.P.
8 as Local Counsel for the Official Committee of Unsecured Creditors” attached hereto as **Exhibit**
9 **B** (“Supporting Affidavit”), and respectfully represents as follows:

10 **I. BACKGROUND**

11 1. On January 22, 2015 (the “Petition Date”), the Debtors filed with this Court their
12 voluntary petitions for relief under Chapter 11 of the Bankruptcy Code.

13 2. Pursuant to Sections 1107 and 1108 of the Bankruptcy Code, the Debtors are
14 continuing to manage their property and assets as debtors-in-possession. No trustee or examiner
15 has been appointed in the Debtors’ Chapter 11 cases.

16 3. The Committee’s primary counsel is Cooley, LLP, with its primary place of
17 business based in New York.

18 4. This Court has jurisdiction to hear this Application pursuant to 28 U.S.C. §§ 1334
19 and 157. This Application represents a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A) and
20 (O). Venue in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409. The statutory
21 predicate for the relief sought herein is § 1103(a) of the Bankruptcy Code.

22 **II. RELIEF REQUESTED**

23 5. The Committee respectfully requests the entry of an Order pursuant to § 1103(a) of
24 the Bankruptcy Code authorizing it to employ and retain Snell & Wilmer as local bankruptcy
25 counsel effective as of February 6, 2015. A proposed order is attached hereto as **Exhibit A**.

26 6. The Committee needs local bankruptcy counsel if it is to effectively participate in
27 these Chapter 11 cases. The Committee has selected Snell & Wilmer to be its local counsel
28 because the firm has considerable experience in such cases and is well qualified to represent it as

1 local bankruptcy counsel in these cases.

2 **III. SERVICES TO BE RENDERED**

3 7. The Committee believes that it would be most efficient and in the best interests of
4 its estate that Snell & Wilmer be retained, pursuant to § 1103(a) of the Bankruptcy Code, as local
5 counsel to perform the legal services that will be necessary during the pendency of these Chapter
6 11 cases, as more fully described herein. Certain of the necessary professional services to be
7 rendered by Snell & Wilmer include, without limitation, the following:

- 8 a. Attend the meetings of the Committee;
- 9 b. Review financial and operational information furnished by the Debtors to
10 the Committee;
- 11 c. Assist in the efforts to sell assets of the Debtors in a manner that
12 maximizes value for creditors;
- 13 d. Analyze any proposed Chapter 11 plan;
- 14 e. Review and investigate prepetition transactions in which the Debtors
15 and/or their insiders were involved;
- 16 f. Confer with the Debtors' management, counsel and financial advisors;
- 17 g. Review the Debtors' schedules, statements of financial affairs and business
18 plan;
- 19 h. Advise the Committee as to the ramifications regarding all of the Debtors'
20 activities and motions before this Court;
- 21 i. File appropriate pleadings on behalf of the Committee;
- 22 j. Review and analyze the Debtors' investment banker's work product and
23 report to the Committee;
- 24 k. Provide the Committee with legal advice in relation to the chapter 11 cases;
- 25 l. Prepare various applications and memoranda of law submitted to the Court
26 for consideration; and
- 27 m. Perform such other legal services for the Committee as may be necessary
28 or proper in these proceedings.

8. Snell & Wilmer has indicated its willingness to act on the Committee's behalf in
the capacities designated above.

27 **IV. COMPENSATION**

28 9. Subject to Court approval, and in accordance with §§ 330 and 331 of the

1 Bankruptcy Code, compensation to Snell & Wilmer shall be based on its standard hourly rates for
2 professional services and reimbursement of those costs and other expenses for which the firm
3 typically seeks reimbursement, including, among other things, telephone and facsimile toll
4 charges, express mail and mass mail postage charges, special or hand-delivery charges,
5 photocopying charges, travel expenses, expenses for computerized research, transcription costs,
6 as well as non-ordinary overhead expenses. The firm will charge the Committee for these
7 expenses in a manner and at rates consistent with charges made generally to the firm's other
8 clients.

9 10. The primary attorneys and paralegals that may be designated to represent the
10 Committee and their current, standard hourly rates are:

15 These hourly rates are subject to periodic adjustment to reflect economic and other conditions, as
16 well as counsel's experience and expertise in this area of law. In addition to those identified
17 above, other attorneys and paralegals employed by Snell & Wilmer may from time to time serve
18 the Committee in connection with the matters herein described. Snell & Wilmer will make
19 periodic applications for interim compensation, and upon the completion of the case, application
20 for final compensation.

21 11. No agreement exists between Snell & Wilmer or any other person for the sharing
22 of compensation to be received by Snell & Wilmer in connection with services rendered in these
23 cases.

24 **V. DISINTERESTEDNESS**

25 12. To the best of applicant's knowledge, Snell & Wilmer does not hold or represent
26 any entity having an adverse interest in connection with this case.

27 13. As set forth in the Supporting Affidavit, Snell & Wilmer discloses to the
28 Committee and the Court all presently known connections of Snell & Wilmer with the Debtors,

1 creditors, and interest holders. Given that there are numerous creditors and the Debtor has not yet
2 filed its schedules and statement of financial affairs, Snell & Wilmer has not been able to finalize
3 its review to determine which creditors of the Debtors, if any, Snell & Wilmer has represented in
4 the past, or continues to represent.

5 14. To the best of Snell & Wilmer's and the Committee's knowledge, information, and
6 belief pursuant to the information available, Snell & Wilmer believes that (i) its proposed role as
7 local counsel to the Committee presents no adverse interest to the Committee in this case, and
8 (ii) it is otherwise disinterested as that term is defined in 11 U.S.C. § 101(14). Therefore, Snell &
9 Wilmer's retention by the Committee under 11 U.S.C. § 1103(a) is proper and appropriate.

10 **VI. NOTICE**

11 15. Notice of this Application has been given to the Office of the United States
12 Trustee for the District of Arizona, and to the Official Service List established by this Court's
13 Order dated January 29, 2015 (Dkt 47).

14 WHEREFORE, the Committee respectfully requests the entry of an order authorizing the
15 retention of Snell & Wilmer, effective as of February 6, 2015, to represent the Committee. The
16 Committee requests such other and further relief as is just and proper.

4 I, Steven D. Jerome, being first duly sworn upon oath, and pursuant to Fed. R. Bankr. P.
5 2014 and 2016, and 11 U.S.C. §§ 1103(a), state as follows:

6 1. I am a partner with the law firm of Snell & Wilmer L.L.P. (“Snell & Wilmer”),
7 which maintains offices in Phoenix and Tucson, Arizona; Salt Lake City, Utah; Denver,
8 Colorado; Los Angeles and Costa Mesa, California; Las Vegas and Reno, Nevada; and San Jose
9 del Cabo, Mexico.

10 2. Snell & Wilmer, its partners, associates, and paraprofessionals are experienced in
11 matters of bankruptcy, insolvency, corporate reorganization, and debtor/creditor law, and in the
12 representation of debtors, creditors, creditors’ committees and trustees in cases under the
13 Bankruptcy Code and are well qualified to provide legal representation in the above-captioned
14 case.

15 3. On January 22, 2015 (the “Petition Date”), the Debtors filed their voluntary
16 petitions for relief under Chapter 11, Title 11, of the United States Code.

17 4. This Affidavit is submitted in support of the “Application to Employ Snell &
18 Wilmer as Local Counsel for the Official Committee of Unsecured Creditors” (the “Application”)
19 filed concurrently herewith.

20 5. Subject to approval by the Court, and in accordance with Sections 330 and 331 of
21 the Bankruptcy Code, compensation to Snell & Wilmer shall be based on its standard hourly rates
22 for professional services and reimbursement of those costs and other expenses for which the firm
23 typically seeks reimbursement, including, among other things, telephone and facsimile toll
24 charges, express mail and mass mail postage charges, special or hand-delivery charges,
25 photocopying charges, scanning charges, travel expenses, expenses for computerized research,
26 transcription costs, as well as non-ordinary overhead expenses.

27 6. Snell & Wilmer will charge the Committee for these expenses in a manner and at
28 rates consistent with charges made generally to the firm’s other clients and as is customary for
law firms providing similar services in the Phoenix market.

13 8. Snell & Wilmer has not received any funds from the Committee or any of its
14 members.

15 9. No agreement exists between Snell & Wilmer or any other person for the sharing
16 of compensation to be received by Snell & Wilmer in connection with services rendered in these
17 cases.

18 10. To determine whether Snell & Wilmer has any connections with the Debtors,
19 United States Trustee, or any creditors, I reviewed Snell & Wilmer's records and assembled other
20 pertinent information, including a search using Snell & Wilmer's computerized conflict search
21 system. In particular, I directed that a search of the Debtors, the United States Trustee's Office,
22 and all entities listed by the Debtors to date on the master mailing list, be conducted. A list of the
23 entities searched is attached hereto as **Exhibit "1"** and incorporated herein by this reference.

24 11. A review of the search revealed that Snell & Wilmer has a current relationship
25 with certain of those entities, which are identified on the attached **Exhibit "2"** and incorporated
26 herein by this reference. Additionally, attached as **Exhibit "3"** and incorporated herein by this
27 reference is a list of entities and persons with which Snell & Wilmer was unable to determine
28 whether it has a current relationship. Except as disclosed herein, Snell & Wilmer's relationship

1 with all entities contained herein is unrelated to the Debtors or their bankruptcy cases. In general,
2 Snell & Wilmer was retained by certain of those entities to provide legal advice and services
3 relating to commercial litigation, and/or corporate, investing, real estate acquisition, and lending
4 transactions unrelated to the above mentioned cases or Debtors.

5 12. Given that Debtors just filed their schedules and statements of financial affairs, as
6 set forth above, Snell & Wilmer has not been able to finalize its review to determine if it has
7 represented in the past, or continues to represent, certain creditors of the Debtor.

8 13. Additionally, in the ordinary course of its business, Snell & Wilmer appears in
9 numerous cases, proceedings and transactions that involve many different types of professionals,
10 such as attorneys, accountants and financial experts, who may represent claimants and parties-in-
11 interest in the Debtors' cases. Snell & Wilmer has in the past, may currently, and will likely in
12 the future be working with or against other professionals involved in these bankruptcy cases in
13 matters unrelated to the Debtors' bankruptcy case. Based on our current knowledge of the
14 professionals involved, and to the best of my knowledge, none of these relationships create
15 interests materially adverse to the Committee in matters upon which Snell & Wilmer is to be
16 employed, and none are in connection with these bankruptcy cases.

17 14. Accordingly, to the best of my knowledge, information, and belief, pursuant to the
18 information available, I believe that (i) Snell & Wilmer's proposed role as local counsel to the
19 Committee presents no adverse interest to the Committee, the creditors or parties in interest in
20 this case; and (ii) it is otherwise disinterested as that term is defined in 11 U.S.C. § 101(14).
21 Therefore, I believe that Snell & Wilmer's retention by the Committee under 11 U.S.C. § 1103(a)
22 is proper and appropriate.

23 15. Snell & Wilmer will supplement and amend the Application should it discovery
24 any representations or connections that require disclosure in this case.

25 16. Snell & Wilmer is not aware at this time of all the other attorneys and
26 professionals who may be employed in this case. It will supplement the Application with any
27 connections to such professionals in conjunction with its supplementation after the schedules are
28 prepared and filed.

("Snell") as local counsel *nunc pro tunc* to February 6, 2015, the date the Committee determined to employ Snell as local counsel in these cases, pursuant to section 1103 of title 11 of the United States Code; and upon the Affidavit of Counsel in Support of Application to Employ Snell & Wilmer LLP as Local Counsel for the Official Committee of Unsecured Creditors Nunc Pro Tunc to February 6, 2015 (the "Jerome Affidavit") attached to the Application as **Exhibit A**; and the

1 Court having jurisdiction pursuant to sections 157 and 1334 of title 28 of the United States Code
2 to consider the Application and the relief requested therein; and venue being proper in this Court
3 pursuant to sections 1408 and 1409 of title 28 of the United States Code; and the Court being
