**SUPPLEMENT B PILOT BENEFICIARIES’
OBJECTION TO PLAN CONFIRMATION**

The Supplement B Pilot Beneficiaries (“Supplement B Pilots”) hereby file this objection to confirmation of the Debtors’ Second Amended Joint Chapter 11 Plan. The Supplement B Pilots object on the grounds that Plan Confirmation should be postponed until after resolution of the Supplement B Pilots’ three pending District Court appeals, which are described below:

1. Appeal of the Sept. 5, 2012 order authorizing abrogation of Supplement B of the Collective Bargaining Agreement between American Airlines and the Allied Pilots Association. Doc. No. 4293. The appeal was docketed as No. 12-cv-7800 and was assigned to Judge Colleen McMahon. All briefing was complete as of April 30, 2013.

2. Appeal of the Dec. 19, 2012 order granting the Debtors' motion for authorization to eliminate the lump sum option from the pilots' retirement benefit plan. Doc. No. 5797. The appeal was docketed as No. 12-cv-958 and was assigned to Judge Colleen McMahon. All briefing was complete as of April 30, 2013.

3. Appeal of the Dec. 19, 2012 order authorizing American to enter into a new collective bargaining agreement with the Allied Pilots Association. Doc. No. 5800. The appeal was docketed as No. 12-cv-959 and was assigned to Judge Colleen McMahon. All briefing was complete as of April 30, 2013.

In order to preserve the Supplement B Pilots' rights to effective relief with respect to the above appeals, it is respectfully requested that the Court postpone Plan Confirmation until after the above District Court appeals are decided.
