Cause exists, pursuant to sections 102(1)(B) and 105 of the Bankruptcy Code and Bankruptcy Rules 2002(i), 9006(c) and 9007 limiting notice of the Application to the following parties, or their respective attorneys of record: (i) the office of the United States Trustee for Region IX; (ii) each of Debtors' secured lenders (KeyBank, National Association, Huntington National Bank and Bank of America, NA); (iii) counsel for the Agent for Debtors' secured lenders; (iv) counsel for the Official Committee of Unsecured Creditors; (v) and all other parties who have appeared and requested notice pursuant to Bankruptcy Rule 2002.
4. Notice of the Application to other parties shall not be required.
