**MOTION OF THE DEBTORS FOR AN ORDER PURSUANT TO 11 U.S.C. §§ 105(a),
363(b), 507(a)(8) AND 541(d), (I) AUTHORIZING PAYMENT OF CERTAIN TAXES
AND FEES AND (II) AUTHORIZING AND DIRECTING BANKS AND FINANCIAL
INSTITUTIONS TO HONOR AND PROCESS RELATED CHECKS AND TRANSFERS**

The above-captioned debtors and debtors-in-possession (collectively, the “**Debtors**”) file this motion (the “**Motion**”) for entry of an order pursuant to 11 U.S.C. §§ 105(a), 363(b), 507(a)(8) and 541(d), (I) authorizing payment of certain taxes as well as fees, licenses and other similar charges and assessments as Debtors, in their discretion, deem necessary or appropriate and (II) directing banks and financial institutions to honor and process related checks and transfers.² In support of this Motion, the Debtors respectfully state as follows:³

JURISDICTION

1. The Court has jurisdiction over this Motion under 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2). Venue of this proceeding and this Motion in this District is proper under 28 U.S.C. §§ 1408 and 1409.

2. The statutory bases for the relief requested herein are Sections 105(a), 363(b), 507(a)(8) and 541(d) of title 11 of the United States Code, 11 U.S.C. §§ 101 et seq. (as amended, the “**Bankruptcy Code**”).

BACKGROUND

3. On June 17, 2009 (the “**Petition Date**”), Eddie Bauer Holdings, Inc. and each of its Debtor affiliates filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code (collectively, the “**Chapter 11 Cases**”). The Debtors intend to continue in the possession of their respective properties and the management of their respective businesses as debtors in possession pursuant to Sections 1107 and 1108 of the Bankruptcy Code. The Debtors have requested that these Chapter 11 Cases be consolidated for procedural purposes. As of the date hereof, no trustee, examiner or statutory committee has been appointed in these Chapter 11 Cases.

4. Subsequent to the commencement of these Chapter 11 Cases, the Debtors’ two Canadian affiliates – Eddie Bauer of Canada, Inc. and Eddie Bauer Customer Services, Inc. (the “**Canadian Debtor Affiliates**”) – will seek recognition of the Debtors’ Chapter 11 Cases in a Canadian Court as “foreign proceedings” pursuant to Section 18.6 of the Companies’ Creditors Arrangement Act, R.S.C. 1985, c. C-36, as amended. In addition to staying proceedings against the Canadian Debtor Affiliates in Canada, such recognition by the Canadian Court will allow certain orders of this Court to be in full force and effect in the same manner and in all respects as

if they had been made by the Canadian Court. Due to the integrated management of the Canadian Debtor Affiliates with the Debtors' U.S. operations, as well as the role that the Canadian Debtor Affiliates play in the Debtors' overall prepetition debt structure, these Chapter 11 Cases will function as the main proceedings with respect to the Canadian Debtor Affiliates.

5. As further detailed in the First Day Declaration, the Debtors and the Canadian Debtor Affiliates⁴ are a publicly traded general merchandise and specialty retailer that offers men's and women's outerwear, apparel, accessories and gear for an active outdoor lifestyle through catalogs, e-commerce sites and over 370 retail and outlet stores. The Debtors have 556 full-time, part-time, and temporary employees in their corporate headquarters, and 7,144 full-time, part-time, and temporary retail and distribution employees. The Canadian Affiliates have over 950 full-time, part-time, and temporary employees working in management, retail and customer service.

THE PROPOSED 363 SALE

6. Due to (i) Debtors' and Debtors' lenders inability to agree upon the terms of a consensual restructuring, (ii) the Debtors' need to reduce debt load and interest expenses, and (iii) the Debtors' mounting concerns regarding the potential deterioration of their businesses – and accompanying degradation in value – stemming from rumors in the marketplace about the Debtors' liquidity and viability, the Debtors have determined that the value of their estates would be best maximized and preserved through a sale process (the "**Sale**"). Therefore, the Debtors have negotiated a going-concern Sale of their businesses and assets (the "**Assets**") to Rainier Holdings LLC as the stalking horse bidder (the "**Stalking Horse Bidder**") pursuant to an asset

purchase agreement and commenced these Chapter 11 Cases to implement the Sale pursuant to Section 363 of the Bankruptcy Code, subject to a competitive Sale process and the solicitation of higher and/or otherwise better offers. The Debtors believe that unless the Sale is expeditiously consummated, whether to the proposed Stalking Horse Bidder or to a purchaser submitting a higher or otherwise better offer, there will be significant value deterioration. Consequently, the Debtors have determined that it is in the best interest of their estates, creditors and other parties-in-interest to move forward with the Sale process.

7. The events leading up to the Petition Date and the Sale and the facts and circumstances supporting the relief requested herein are more fully set forth in the First Day Declaration.

RELIEF REQUESTED

8. The Debtors seek authority, pursuant to Sections 105(a), 363(b), 507(a) and 541(d) of the Bankruptcy Code, in their sole discretion, to pay all sales, use, franchise, real and personal property taxes, business license fees and annual report taxes in the approximate aggregate amount of \$7,375,000⁵ (collectively, the “**Taxes**”), owed to certain taxing authorities (collectively, the “**Taxing Authorities**”, a listing of which is annexed hereto as Exhibit B), including all Taxes subsequently determined upon audit to be owed for periods prior to the Petition Date,⁶ by whatever means the Debtors may deem appropriate, including, without limitation, the issuance of post-petition checks and electronic transfers. Such relief will be without prejudice to the Debtors’ rights to contest the amount of any Taxes on any grounds they deem appropriate.

9. In addition, the Debtors seek an order authorizing and directing the Debtors' various banks and financial institutions to receive, process, honor and pay the Debtors' checks or electronic transfers sent to the applicable Taxing Authorities with respect to the Taxes, whether such checks or transfers were issued before or after the Petition Date.

THE DEBTORS' TAX OBLIGATIONS

A. Sales Taxes and Use Taxes

10. In the ordinary course of business, the Debtors collect from their customers and remit to the Taxing Authorities an assortment of sales and local gross receipts taxes (collectively, the "Sales Taxes"). The Sales Taxes are paid to the Tax Authorities on a periodic basis, typically monthly, for Sales Taxes collected during the previous period. However, some Taxing Authorities require the Debtors to prepay the Sales Taxes.

11. The Debtors may also be responsible for the payment of use taxes (the "Use Taxes" and with the Sales Taxes, the "Sales and Use Taxes") when they purchase any tangible personal property from vendors. Use Taxes arise when the Debtors purchase equipment from a vendor for use in a state in which the vendor has no business operations. Without such a nexus, the vendor is not obligated to charge or remit sales taxes for sales parties within the state. Nevertheless, the purchasers, in this case the Debtors, may be obligated to self assess and pay the Use Taxes to the states in which the personal property is used. The Debtors generally remit the Use Taxes to the Taxing Authorities on a monthly basis. The Debtors estimate that they owe approximately \$6,750,000 in Sales and Use Taxes to certain of the Taxing Authorities for periods prior to and including the Petition Date.⁷

B. Franchise Tax

12. The Debtors pay franchise taxes (the "**Franchise Taxes**") to certain of the Taxing Authorities to operate their businesses in the applicable taxing jurisdiction. Some states assess a flat Franchise Tax on all businesses, and other states assess a Franchise Tax based upon net operating income or other measurement. In addition, certain states impose personal liability on the directors and officers of a corporation if that corporation fails to pay Franchise Taxes. The Debtors estimate they owe an aggregate amount of approximately \$107,500⁸ in Franchise Taxes to certain of the Taxing Authorities for periods prior to and including the Petition Date.⁹

C. Real and Personal Property Taxes

13. In addition, under applicable law, state and local governments in jurisdictions where the Debtors' operations are located are granted the authority to levy property taxes against the Debtors' real and personal property (the "**Property Taxes**"). The Debtors typically pay the Property Taxes in the ordinary course of business as such taxes are invoiced, which typically covers Property Taxes for the prior year or quarter, depending on how the applicable tax is assessed. The Debtors estimate that, as of the Petition Date, approximately \$500,000¹⁰ in Property Taxes have accrued.

D. Business License Fees and Annual Report Taxes

14. Many municipal and county governments require the Debtors to obtain a business license or permit and to pay corresponding business license fees (the "**Business License Fees**"). The criteria requiring a company to obtain a business license or permit and the manner in which the Business License Fees are computed vary greatly according to the local tax laws. Some

jurisdictions assess Business License Fees based on a flat rate and others upon the number of employees working in the jurisdiction. Certain state governments also require the Debtors to pay annual report taxes (the “**Annual Report Taxes**”) in order to be in good standing for purposes of conducting business within that state. The Debtors estimate they owe approximately \$17,500 in prepetition Business License Fees and Annual Report Taxes.¹¹

E. Method of Payment

15. The Debtors pay the Taxes described herein to the Taxing Authorities on a periodic basis with funds drawn by checks or by means of electronic fund transfers.

16. The Debtors seek authority to pay all Taxes due and owing to the Taxing Authorities, including all Taxes subsequently determined upon audit to be owed for periods prior to the Petition Date. To the extent any check or electronic transfer has not cleared the banks and financial institutions as of the Petition Date, the Debtors request this Court to authorize and direct the banks and financial institutions, when requested by the Debtors in their sole discretion, to receive, process, honor and pay such checks or electronic transfers. To the extent the Taxing Authorities have otherwise not received payment for all Taxes owed, the Debtors seek authorization to issue replacement checks, or to provide for another means of payment to the Taxing Authorities, to the extent necessary to pay all outstanding Taxes.

BASIS FOR RELIEF

A. The Court Should Permit the Debtors, in Their Discretion, to Pay Taxes.

17. The relief requested in this Motion should be granted for the following reasons:

- (a) a portion of the Taxes may be “trust fund” taxes that are not property of the Debtors’ estates;
- (b) Sections 105 and 363(b) of the Bankruptcy Code and the Court’s general equitable powers

permit the Court to grant the relief sought herein; (c) portions of the Taxes may be entitled to priority status pursuant to Section 507(a)(8) of the Bankruptcy Code; and (d) the Debtors' directors and officers may be personally liable for portions of the Taxes and Taxing Authorities may sue the Debtors' directors and officers for unpaid Taxes, distracting the directors and officers from the Debtors' Sale efforts.

18. First, certain of the Taxes might be "trust fund" Taxes that are not property of the estate. Section 541(d) of the Bankruptcy Code provides, in relevant part, that "[p]roperty in which the debtor holds, as of the commencement of the case, only legal title and not an equitable interest . . . becomes property of the estate under subsection (a)(1) or (a)(2) of this section only to the extent of the Debtors' legal title to such property, but not to the extent of any equitable interest in such property that the debtor does not hold." 11 U.S.C. § 541(d).

19. Many of the Taxes may constitute "trust fund" Taxes, which are required to be collected from the Debtors' customers and held in trust for payment to the Taxing Authorities. See, e.g., Be gier v. IRS, 496 U.S. 53, 57-60 (1990) (holding that any prepetition payment of trust fund taxes is not an avoidable preference since funds are not the debtor's property); DeChiaro v. N.Y. State Tax Comm'n, 760 F.2d 432, 435-36 (2d Cir. 1985); see also In re Al Copeland Enters., Inc., 133 B.R. 837 (Bankr. W.D. Tex. 1991); DuCharmes & Co. v. Michigan, 852 F.2d 194 (6th Cir. 1988) (*per curiam*) (same); Shank v. Wash. State Dep't of Revenue, Excise Tax Div. (In re Shank), 792 F.2d 829, 833 (9th Cir. 1986) (sales tax required by state law to be collected by sellers from their customers is a "trust fund" tax and not released by bankruptcy discharge); In re Shreve Steel Erection, Inc., 92 B.R. 214 (Bankr. W.D. Mich. 1988); In re Marantha Trucking Co., 1988 WL 212742 (Bankr. N.D. Ohio Dec. 22, 1988). To the extent these "trust fund" taxes are collected, they are not property of the Debtors' estates under Section

541(d) of the Bankruptcy Code. See Begier, 496 U.S. at 59; In re Am. Int'l Airways, Inc., 70 B.R. 102, 104-05 (Bankr. E.D. Pa. 1987). The Debtors, therefore, generally do not have an equitable interest in funds held on account of such “trust fund” Taxes, and the Debtors should be permitted to pay those funds to the Taxing Authorities as they become due.¹²

20. Moreover, to the extent that any of the Taxes do not constitute “trust fund” taxes in a particular jurisdiction, the court may rely on its equitable powers under Section 105(a) of the Bankruptcy Code to authorize the Debtors to pay prepetition tax obligations. Section 105(a) of the Bankruptcy Code states, in part, “the court may issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of this title.” 11 U.S.C. § 105(a). Courts frequently authorize debtors-in-possession to pay prepetition obligations to protect the value and assets of the estate and to ensure a smooth continuation of the debtor’s business, pursuant to 11 U.S.C. § 105(a), under the “doctrine of necessity.” See In re Ionosphere Clubs, Inc., 98 B.R. 174, 175-76 (Bankr. S.D.N.Y. 1989) (noting that bankruptcy courts commonly use their equitable powers to authorize the payment of prepetition debts when such payment is needed for the debtor’s restructuring); see also In re NVR L.P., 147 B.R. 126, 127 (Bankr. E.D. Va. 1992) (finding Section 105(a) authorizes a court to “permit pre-plan payment of a prepetition obligation when essential to the continued operation of the debtor”).

21. This Court may also authorize the Debtors to pay Taxes under Section 363(b) of the Bankruptcy Code, which provides that “[t]he trustee, after notice and an hearing, may use, sell, or lease, other than in the ordinary course of business, property of the estate.” 11 U.S.C. § 363(b)(1). Under Section 363(b), a court may authorize a debtor to pay certain prepetition claims. See Ionosphere Clubs, 98 B.R. at 175 (affirming lower court order authorizing payment

of prepetition wages pursuant to Section 363(b) of the Bankruptcy Code). To do so, “the debtor must articulate some business justification, other than the mere appeasement of major creditors.” Id.; see also Comm. of Equity Sec. Holders v. Lionel Corp. (In re Lionel Corp.), 722 F.2d 1063 (2d Cir. 1983).

22. The relief requested herein easily satisfies the foregoing standards. Failure to pay the Taxes to the Taxing Authorities in full and on time, thereby risking the Taxing Authorities’ cessation of normal relations with the Debtors, will make these estates worse off than they will be with payment. Failure to timely pay, or a precautionary withholding by the Debtors of payment of such Taxes would likely cause the Taxing Authorities to take precipitous action, including a marked increase in audits (which would unnecessarily divert the Debtors’ attention from the Sale process to the detriment of all parties in interest). Prompt and regular payment of the Taxes would avoid any such unwarranted governmental action. In many cases, payment of Taxes may actually reduce the amounts ultimately paid to the Taxing Authorities because penalties and interest will be avoided by prompt payment. Further, failure to pay the Taxes and any action that would upset the Taxing Authorities would jeopardize and surely reduce the Debtors’ going concern value and prospects for consummating the Sale. Thus, granting the relief requested in this Motion will maximize the value of the estate’s assets and thus benefit the estate’s creditors.

23. In addition, all or most of the Taxes may be entitled to priority status under Section 507(a)(8) of the Bankruptcy Code and, therefore, must be paid in full under any chapter 11 plan before any of the Debtors’ general unsecured obligations may be satisfied. See 11 U.S.C. § 1129(a)(9)(C). Thus, payment of these taxes at this time likely only affects the timing

of payment and not the amounts that would ultimately be received by the Taxing Authorities and therefore does not prejudice the rights of other creditors.

24. Furthermore, in some cases, state Taxing Authorities could assert that the Debtors' officers and directors are personally liable if the Debtors fail to meet the obligations imposed upon them to remit Taxes that are trust fund obligations. To the extent such accrued Taxes of the Debtors were unpaid as of the Petition Date, the Debtors' officers and directors may be subject to lawsuits in certain jurisdictions during the pendency of these Chapter 11 Cases, even if the failure to pay such Taxes was not a result of any malfeasance on their part. These potential lawsuits would prove extremely distracting for the Debtors, for the named officers and directors and for this Court. Therefore, it is in the best interests of the Debtors' estates and the Debtors' prospects for reorganization to eliminate the possibility of the foregoing distractions.

25. The Debtors submit that the timely payment of the Taxes is necessary to avoid immediate and irreparable harm to the Debtors and their estates and in the best interests of the Debtors, their estates and their creditors. Indeed, Delaware bankruptcy courts routinely grant the relief requested herein. See, e.g., In re Pierre Foods, Inc., No. 08-11480 (KG) (Bankr. D. Del. Aug. 13, 2008); In re Tropicana Entm't, LLC, No. 08-10856 (KJC) (Bankr. D. Del. May 6, 2008); In re Leiner Health Prods. Inc., No. 08-10446 (KJC) (Bankr. D. Del. Apr. 4, 2008); In re Delta Financial Corp., No. 07-11880 (CSS) (Bankr. D. Del. Dec. 18, 2007); In re Tweeter Home Entm't Group, Inc., No. 07-10787 (PJW) (Bankr. D. Del. June 13, 2007). For the foregoing reasons, the Debtors submit that the relief requested herein is in the best interests of the Debtors, their estates and creditors, and therefore should be granted.

26. With respect to Property Taxes, the law in most, if not all, of the jurisdictions in which the Debtors' operations are located provides for the creation of a statutory lien on the

Debtors' real and personal property if the applicable Property Taxes are not paid. Such statutory tax liens typically arise on or relate back to a date prior to the due date of the taxbill (e.g., the assessment date or tax status date).¹³

27. Due to these statutory tax liens, many of the Authorities to which the applicable Property Taxes are owed may hold oversecured claims against the Debtors' estates. Under Section 506(b) of the Bankruptcy Code, such claims may accrue interest. See, e.g., United States v. Ron Pair Enters., Inc., 489 U.S. 235, 241-43 (1989) (nonconsensual lienholders may receive interest on their claims under Section 506(b) of the Bankruptcy Code). To the extent federal and state law requires the Debtors to pay interest on such tax claims, Section 511 of the Bankruptcy Code provides that "the rate of interest shall be the rate determined under applicable nonbankruptcy law." 11 U.S.C. § 511(a). The Debtors believe that the applicable statutory rates of interest for most of the jurisdictions in which the Debtors' operations are located range from the market rate of interest plus a 10% penalty to 18% per annum — rates that in some cases substantially exceed the current market interest rates. See, e.g., Ohio Rev. Code §§ 5719.041, 5719.03(D) (Market rate plus 10%); 35 Ill. Comp. Stat., ch. 35, § 200/21-15 (18% per annum).

28. Moreover, even if the applicable Property Taxes are unsecured, claims for the Property Taxes most likely would be priority claims entitled to payment prior to general unsecured creditors. See 11 U.S.C. § 507(a)(8)(B) (i.e., a "property tax incurred before the commencement of the case and last payable without penalty after one year before the date of the filing of the petition"). To the extent that the Property Taxes are entitled to eighth priority treatment under Section 507(a)(8)(B) of the Bankruptcy Code, the governmental units also may attempt to assess penalties. See 11 U.S.C. § 507(a)(8)(G) (granting eighth priority status to "a

penalty related to a claim of a kind specified in this paragraph and in compensation for actual pecuniary loss”).

29. Consequently, payment of the Property Taxes will give the governmental entities no more than that to which they otherwise would be entitled under a chapter 11 plan and will save the Debtors the potential interest expense (and penalties) that otherwise might accrue on the Property Taxes during the Chapter 11 Cases. Accordingly, the Debtors seek authority, but not direction, to pay Property Taxes to avoid the further accrual of interest and penalties with respect to such Taxes. Such payment shall not be deemed to be a waiver of rights regarding the extent, validity, perfection or possible avoidance of liens and payments.

30. Bankruptcy courts in this and other districts routinely have authorized the payment of Property Taxes in other large chapter 11 cases. See, e.g., In re Tropicana Entm't, LLC, Case No. 08-10856 (KJC) (Bankr. D. Del. May 6, 2008) (authorizing payment of real and personal property taxes); In re Calpine Corp., Case No. 05-60200 (BRL) (Bankr. S.D.N.Y. Dec. 27, 2005) (authorizing payment of prepetition property taxes); In re NRG Energy, Inc., Case No. 03-13024 (PCB) (Bankr. S.D.N.Y. Sept. 18, 2003) (same); In re Teleglobe Comm. Corp., Case No. 02-11518 (MFW) (Bankr. D. Del. May 28, 2002) (authorizing payment of real and personal property taxes); In re Formica Corp., Case No. 02-10969 (BRL) (Bankr. S.D.N.Y. Mar. 5, 2002) (authorizing payment of prepetition property taxes); In re Enron Corp., Case No. 01-16034 (AJG) (Bankr. S.D.N.Y. Dec. 3, 2001) (same); In re USG Corp., Case No. 01-2094 (JKF) (Bankr. D. Del. Sept. 20, 2001) (authorizing payment of real and personal property taxes).

31. Notwithstanding the foregoing, nothing in this Motion should be construed as: (a) an admission as to the validity or priority of any claim against the Debtors; (b) a waiver of the

Debtors' rights to dispute any claims or (c) an approval or assumption of any agreement, contract or lease, pursuant to Section 365 of the Bankruptcy Code.

B. The Court Should Authorize and Direct Banks and Financial Institutions to Honor the Debtors' Taxes

32. The Debtors also request that all banks and financial institutions be authorized and directed to receive, process, honor and pay all checks presented for payment, and to honor all electronic payment requests made by the Debtors related to the prepetition Tax obligations described herein, whether such checks were presented or electronic requests were submitted prior to or after the Petition Date. The Debtors further request that all such banks and financial institutions be authorized and directed to rely on the Debtors' designation of any particular check or electronic payment request as approved pursuant to this Motion.

C. The Requirements of Bankruptcy Rule 6003 Have Been Satisfied.

33. Rule 6003 of the Federal Rules of Bankruptcy Procedure empowers a court to grant relief within the first twenty days after the petition date "to the extent that relief is necessary to avoid immediate and irreparable harm." Fed. R. Bankr. P. 6003.

34. As discussed above, the Taxing Authorities may assert that the Debtors' directors and officers are personally liable if the Debtors fail to meet the obligations imposed upon them to remit the Taxes. Thus, if the relief is not granted, the Debtors' directors and officers may be subject to personal tax-related lawsuits that would cause the Debtors' estates immediate and irreparable harm by detracting from the Sale efforts. Accordingly, the Debtors meet the "immediate and irreparable harm" standard of Rule 6003.

NOTICE

35. No trustee, examiner or creditors' committee has been appointed in the Chapter 11 Cases. The Debtors have provided notice of this Motion to: (a) the United States Trustee for the District of Delaware; (b) counsel to administrative agent under the prepetition term loan facility; (c) counsel to the steering committee for the prepetition term lenders; (d) counsel to agent under the prepetition revolving credit facility; (e) counsel for the indenture trustee for the \$75 million 5.25% convertible senior notes due 2014 and (f) the creditors listed on the Debtors' consolidated list of 30 largest unsecured creditors, as filed with the chapter 11 petitions. In light of the nature of the relief requested, the Debtors submit that no further notice is required or needed under the circumstances.

NO PRIOR REQUEST

37. No prior motion for the relief requested herein has been made to this or any other court.

WHEREFORE, the Debtors respectfully request that the Court enter the Order, substantially in the form attached hereto as Exhibit A, pursuant to 11 U.S.C. §§ 105(a), 363(b) and 507(a) (I) authorizing, but not requiring, the Debtors to remit and pay certain taxes as well as fees, license and other similar charges and assessments as the Debtors, in their discretion, deem necessary or appropriate, and (II) directing all banks and financial institutions to honor and process related checks and transfers and (III) granting such other and further relief as the Court deems appropriate.

Upon consideration of the motion (the “**Motion**”)² of the Debtors for entry of an order authorizing the Debtors to (i) authorize, but not require, the payment of certain taxes as well as fees, licenses and other similar charges and assessments as Debtors, in their discretion, deem necessary or appropriate, and (ii) direct banks and financial institutions to honor and process related checks and transfers; and it appearing that this Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and it appearing that this Motion is a core proceeding pursuant to 28 U.S.C. § 157; and adequate notice of the Motion and opportunity for objection having been given; and it appearing that no other notice need be given; and after due deliberation and sufficient cause therefore, it is hereby:

ORDERED, that the Debtors are authorized, but not directed, in their sole discretion, to pay all Taxes in an approximate aggregate amount of \$7,375,000 (including all Taxes subsequently determined upon audit to be owned for periods prior to the Petition Date) by whatever means the Debtors may deem appropriate, including, without limitation, the issuance of postpetition checks and electronic transfers; and it is further

ORDERED, that the Debtors are authorized, but not directed, in their sole discretion to pay all Tax amounts; and it is further

ORDERED, that all banks and financial institutions are authorized and directed to (i) receive, process, honor and pay all checks or electronic transfers sent to a Taxing Authority for Taxes, whether such checks or transfers were issued before or after the Petition Date and (ii) rely on the Debtors' designation of any particular check or electronic payment request as approved by this Order; and it is further

ORDERED, that the Debtors are authorized to reissue any check, wire or electronic payment or transfer (or similar payment) which was drawn or made in payment of any prepetition amount authorized to be paid under this Order and that is not cleared by a depository; and it is further

ORDERED, that upon the payment of any Property Taxes, any lien securing such Property Taxes shall be immediately released, become void and be of no further force or effect; provided, that such payment shall not be deemed to be a waiver of the Debtors' rights regarding the extent, validity, perfection or possible avoidance of the related liens and payments; and it is further

ORDERED, that nothing herein shall impair the Debtors' ability to contest the validity, priority and/or amounts of the Taxes owing to the Taxing Authorities or a waiver of any rights or remedies of the Debtors; and it is further

ORDERED, that the Debtors do not concede that liens (contractual, common law, statutory or otherwise) described in this Motion are valid, and the Debtors expressly reserve the right to contest the extent, validity or perfection or seek the avoidance of all such liens; and it is further

ORDERED, that the Debtors are authorized and empowered to take all actions necessary to implement the relief granted in this Order; and it is further

ORDERED, that nothing in this order shall be construed as (a) a determination of the validity of any claim against the Debtors; or (b) a limitation on the Debtors' right to dispute any claim; and it is further

ORDERED, that Rule 6003(b) of the Federal Rules of Bankruptcy Procedure has been satisfied because the relief requested in the Motion is necessary to avoid immediate and irreparable harm to the Debtors; and it is further

ORDERED, that notwithstanding the possible applicability of Rule 6004(h) of the Federal Rules of Bankruptcy Procedure, or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry; and it is further

ORDERED, that this Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
