**DEBTORS’ SECOND OMNIBUS MOTION FOR ENTRY OF AN ORDER
AUTHORIZING THE REJECTION OF CERTAIN EXECUTORY CONTRACTS
NUNC PRO TUNC TO THE DATE OF FILING OF THIS MOTION**

THIS MOTION SEEKS TO REJECT CERTAIN EXECUTORY CONTRACTS. COUNTERPARTIES RECEIVING THIS MOTION SHOULD LOCATE THEIR NAMES AND THEIR CONTRACTS ON EXHIBIT 1 TO THE PROPOSED ORDER ATTACHED HERETO. PLEASE REVIEW THIS MOTION IN ITS ENTIRETY, INCLUDING EXHIBIT 1 TO THE PROPOSED ORDER ATTACHED HERETO, TO DETERMINE IF THIS MOTION AFFECTS YOUR CONTRACT AND YOUR RIGHTS THEREUNDER.

Insys Therapeutics, Inc. (“**Insys**”) and its affiliated debtors in the above-captioned chapter 11 cases (the “**Chapter 11 Cases**”), as debtors and debtors in possession (collectively, the “**Debtors**”), respectfully represent as follows in support of this motion (the “**Motion**”):

Relief Requested

1. The Debtors seek authority pursuant to sections 105(a) and 365(a) of title 11 of the United States Code (the “**Bankruptcy Code**”) and Rule 6006 of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”) to reject certain executory contracts, identified on **Exhibit 1** to the Proposed Order (defined below) (including any amendments, supplement or

modifications thereto, the “**Rejected Contracts**”), effective as of the date of filing of this Motion (the “**Rejection Date**”).

2. A proposed form of order granting the relief requested in this Motion is attached hereto as **Exhibit A** (the “**Proposed Order**”).

Jurisdiction

3. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334, and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated as of February 29, 2012. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

4. Pursuant to Rule 9013-1(f) of the Local Rules of Bankruptcy Practice and Procedure of the United States Bankruptcy Court for the District of Delaware (the “**Local Rules**”), the Debtors consent to the entry of a final judgment or order with respect to the Motion if it is determined that the Court would lack Article III jurisdiction to enter such final order or judgment absent consent of the parties.

Background

A. General Background

5. On June 10, 2019 (the “**Petition Date**”), the Debtors each commenced with this Court a voluntary case under chapter 11 of the Bankruptcy Code. The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

6. The Chapter 11 Cases are being jointly administered for procedural purposes only pursuant to Bankruptcy Rule 1015(b) and Local Rule 1015-1.

7. On June 20, 2019, the Office of the United States Trustee for the District of Delaware (the “**U.S. Trustee**”) appointed an official committee of unsecured creditors in these Chapter 11 Cases (the “**Committee**”). No trustee or examiner has been appointed in these Chapter 11 Cases.

8. On July 2, 2019, the Court entered the *Order (A) Approving Bidding Procedures for Sale of Debtors’ Assets, (B) Scheduling Auction for and Hearing to Approve Sale of Debtors’ Assets, (C) Approving Form and Manner of Notice of Sale Auction, and Sale Hearing, (D) Approving Assumption and Assignment Procedures, and (E) Granting Related Relief* [Docket No. 210] (the “**Bidding Procedures Order**”). In accordance with the Bidding Procedures Order, the Debtors have sold or are in the process of selling all or substantially all of their assets (the “**Sales Transactions**”). *See* [Docket Nos. 515, 525, 641 and 671].

9. The Sale Transactions include the Debtors sale of their commercial product SYNDROS® (“**Syndros**”) in accordance with an asset purchase agreement entered into between the Debtors and Chilion Group Holdings US, Inc. on August 6, 2019 and approved by the Court on August 22, 2019 [Docket No. 514]. The Debtors’ believe that the closing of Syndros Sale Transaction is imminent. Additionally, on September 19, 2019, the Court entered an order approving the Debtors’ sale to BTcP Pharma LLC of their fentanyl sublingual spray product, SUBSYS® (“**Subsys**”), throughout the world with the exception of certain Asian territories [Docket No. 641]. The Subsys Sale Transaction closed on September 26, 2019. On September 27, 2019, in accordance with the Bidding Procedures Order, the Debtors filed a notice for the sale of specific intellectual property, including patents and rights to the Subsys mark in certain Asian territories, to Pharmbio Korea, Inc. [Docket No. 671]. No party has objected to the

proposed sale to Pharmbio Korea, Inc. and the hearing to approve the transaction is scheduled for October 16, 2019.

10. On September 17, 2019, the Debtors filed a chapter 11 plan [Docket No. 612] and accompanying disclosure statement [Docket No. 613].

11. Additional information regarding the circumstances leading to the commencement of these Chapter 11 Cases and the Debtors' business and capital structure is set forth in the declaration of Andrew G. Long, the Debtors' Chief Executive Officer, filed on the Petition Date [Docket No. 11] (the "**Long Declaration**").²

B. The Rejected Contracts

12. As set forth in the Long Declaration, prior to the Petition Date, the Debtors commercially marketed products — Subsys and Syndros (together, the "**Products**") provided substantially all of the Debtors' revenue. The Products were primarily sold to wholesale pharmaceutical distributors (the "**Distributors**") and specialty retail pharmacies that sell directly to patients (the "**Specialty Pharmacies**," and collectively with the Distributors, the "**Customers**"), pursuant to various contracts with Customers that provide certain incentives, discounts, rebates, and other accommodations (collectively, the "**Customer Programs**").

13. The Rejected Contracts consist primarily of contracts with Distributors or Specialty Pharmacies related to Customer Programs and the Products. In addition to such Customer Program related agreements, the Debtors have also designated contracts for rejection that relate to (a) vendors involved in manufacturing the Products, (b) group purchasing organizations, (c) managed care and commercial rebate programs, (d) voucher and copay programs, (e) sales related data providers, and (f) mileage reimbursement for the Debtors' sale team.

14. The Rejected Contracts no longer confer any benefit to the Debtors or their estates given the Debtors' sale of the Products in connection with the Sales Transactions. Accordingly, any obligations under the Rejections Contracts, including any costs or administrative associated therewith, are unnecessary and burdensome.

Basis for Relief Requested

A. The Rejection of the Rejected Contracts is an Appropriate Exercise of the Debtors' Business Judgment

15. Section 365(a) of the Bankruptcy Code provides, in pertinent part, that a debtor, "subject to the court's approval, may assume or reject any executory contract . . . of the debtor." 11 U.S.C. § 365(a). The bankruptcy court should approve a debtor's rejection of an executory contract if such rejection is an exercise of the debtor's sound business judgment, benefits its estate, and is not made in bad faith. *See In re Bildisco*, 682 F.2d 72, 79 (3d Cir. 1982), *aff'd*, 465 U.S. 513 (1984) ("[t]he usual test for rejection of an executory contract is simply whether rejection would benefit the estate, the 'business judgment' test"); *Sharon Steel Corp. v. Nat'l Fuel Gas Distr. Corp.*, 872 F.2d 36, 39-40 (3d Cir. 1989) (affirming rejection of a service agreement as sound exercise of debtor's business judgment where bankruptcy court found rejection would benefit estate); *In re HQ Global Holdings, Inc.*, 290 B.R. 507, 511 (Bankr. D. Del. 2003) (holding the business judgment standard applicable, absent bad faith, whim, or caprice). In applying the business judgment standard, bankruptcy courts afford great deference to a debtor's decision to assume or reject executory contracts. *See In re Summit Land Co.*, 13 B.R. 310, 315 (Bankr. D. Utah 1981) (absent extraordinary circumstances, court approval of debtor's decision to assume or reject an executory contract "should be granted as a matter of course").

16. As a result of the Sale Transactions, the Debtors have sold or are in the process of selling substantially all of their assets. Upon the closing of such Sale Transactions, the Debtors will have limited operations, if any, aside from those activities that are necessary or appropriate to wind-down their business and confirm and implement a chapter 11 plan. Additionally, prior to the Petition Date, the Debtors entered into a Corporate Integrity Agreement and Conditional Exclusion Release (“CIA”) with the Office of Inspector General for the U.S. Department of Health and Human Services. In accordance with the CIA, as of the date hereof, the Debtors can no longer market and promote Subsys.

17. The Debtors have examined their need for the Rejected Contracts, as the global sale process concludes, and have determined that there is no further need for the services or programs under any Rejected Contract, not now and not in conjunction with the implementation of their liquidating chapter 11 plan. Indeed, it is axiomatic that costs associated with assets that have been or in the process of being sold to third parties should be eliminated. Accordingly, rejecting the Rejected Contracts is a sound exercise of the Debtors’ business judgment as it will, *inter alia*, preserve estate assets by discontinuing unnecessary and burdensome expenses for the Debtors’ estates and therefore maximize distributions to creditors.

B. *Nunc Pro Tunc* Rejection of the Contracts is Appropriate

18. The Debtors respectfully request that the rejection of the Rejected Contracts be effective *nunc pro tunc* to the date hereof. Courts “may exercise their equitable powers in granting such a retroactive order when doing so promotes the purposes of Section 365(a).” *In re Rupari Holding Corp.*, 2017 Bankr. Lexis 4095, at *13 (Bankr. D. Del. Nov. 28, 2017). The retroactive rejection of executory contracts requires the court to “balance the equities” of a case. *Id.* If the equities are in the debtor’s favor, the court may grant retroactive rejection. *Id.*

19. The balance of equities favors the rejection of the Rejected Contracts to be effective *nunc pro tunc* to the date of this Motion. The Debtors are no longer marketing and have sold (or are about to sell) the Products in connection with the Sales Transactions. Accordingly, the estates are not receiving any benefits in continuing to perform under the Rejected Contracts.

20. When permitting retroactive rejection, courts typically make rejection retroactive to the date on which the nondebtor party to the executory contract is given definitive notice of the debtor's intent to reject. *See, e.g., In re Mail Systems Liquidation, Inc.*, Case No. 11-11187 (PJW) (Bankr. D. Del. Oct. 18, 2011) (authorizing rejection of contracts *nunc pro tunc* to date of filing motion). Accordingly, the Debtors will (a) serve notice of this Motion by overnight mail on the counterparties to all of the Rejected Contracts, demonstrating their unequivocal intent to reject the Rejected Contracts; and (b) not withdraw their rejection of any of the Rejected Contracts absent the consent of the relevant counterparties. The Debtors have also made the Committee aware of the filing of this Motion and will further consult with the Committee, as necessary, regarding rejection of the Rejected Contracts. The Debtors believe, therefore, that retroactive rejection effective to the date of filing of this Motion is necessary, appropriate, and in accordance with applicable law.

Reservation of Rights

21. The Debtors may have claims against the counterparties to the Rejected Contracts arising under, or independently of, the Rejected Contracts. The Debtors do not waive such claims by the filing of this Motion or by the rejection of the Rejected Contracts. The Debtors are diligently reviewing and evaluating their remaining contracts and reserve the right to identify additional executory contracts for rejection in the future. This Motion should not be

construed as a determination that any contracts or agreements not described herein are to be assumed or rejected. Nothing contained herein is intended or should be construed as an admission of the validity of any claim against the Debtors, a waiver of the Debtors' rights to dispute any claim, or an approval, assumption, or rejection of any agreement, contract, lease, or sublease under section 365 of the Bankruptcy except as expressly set forth herein.

Waiver of Bankruptcy Rule 6006(f)(6)

22. Bankruptcy Rule 6006(f)(6) requires that an omnibus motion to reject multiple executory contracts “be limited to no more than 100 executory contracts” Fed. R. Bankr. P. 6006(f)(6). However, courts may waive the requirements of Bankruptcy Rule 6006(f)(6). *See In re Old Carco LLC*, 406 B.R. 180, 207-10 (Bankr. S.D.N.Y. 2009) (“Specifically, the 2007 Advisory Committee Notes to Rule 6006 states that “[a]n omnibus motion to assume, assign, or reject multiple executory contracts and unexpired leases must comply with the procedural requirements set forth in subdivision (f) of the rule, unless the court orders otherwise”). Bankruptcy Rule 6006(f)(6) is intended to ensure that lease or contract counterparties can easily locate their information in a debtor’s omnibus motion. *See* 10 Collier on Bankruptcy ¶ 6006.05 (15th ed. rev.).

23. Initially, while the list of Rejected Contracts exceeds 100 items, the vast majority of these items are amendments and other documents that relate to approximately only 35 agreements. Accordingly, the Debtors submit that the Motion complies with Bankruptcy Rule 6006(f)(6). However, out of an abundance of caution, the Debtors respectfully request a waiver of Bankruptcy Rule 6006(f)(6) to the extent necessary. The Debtors have listed the Rejected Contracts in an organized and clear chart that lists each contract counterparty in alphabetical order as required by Bankruptcy Rule 6006(f)(2) and have otherwise complied with all other requirements of Bankruptcy Rule 6006(f). The Debtors further submit

that filing a single motion avoids the confusion and inefficiency that might otherwise result if the Debtors were required to file separate motions requesting the same relief. Courts regularly waive Bankruptcy Rule 6006(f)(6) in similar situations. *See, e.g., Old Carco*, 406 B.R. at 207-10 (permitting more than 100 agreements to be rejected through one motion); *In re Golfsmith International Holdings, Inc.*, Case No. 16-12033 (LSS) (Bankr. D. Del. Jan. 20, 2017) [Docket No. 681] (waiving Bankruptcy Rule 6006(f)(6) and permitting over 100 contracts to be rejected through one motion); *In re Gridway Energy Holdings*, Case No. 14-10833 (CSS) (Bankr. D. Del. Mar. 27, 2015) [Docket No. 894] (waiving Bankruptcy Rule 6006(f)(6) and permitting more than 1,500 executory contracts to be rejected through one motion); *In re Delta Petroleum Corp.*, Case No. 11-14006 (KJC) (Bankr. D. Del. Aug. 16, 2012) [Docket No. 918] (permitting approximately 500 executory contracts and unexpired leases to be assumed and assigned through one motion). Accordingly, the Debtors submit that, to the extent necessary, the Court should grant such waiver here.

Waiver of Bankruptcy Rule 6004(a) and 6004(h)

24. To implement the foregoing successfully, the Debtors request, to the extent Bankruptcy Rule 6004 is applicable to the relief requested herein, that the Court enter an order providing that notice of the relief requested herein satisfies Bankruptcy Rule 6004(a) and that the Debtors have established cause to exclude such relief from the 14-day stay period under Bankruptcy Rule 6004(h) and any other applicable Bankruptcy Rule.

Notice

25. Notice of this Motion has been provided to (a) the Office of the United States Trustee for the District of Delaware (Attn: Jane M. Leamy); (b) the counsel to the Committee; (c) the Securities and Exchange Commission; (d) the Internal Revenue Service; (e) the United States Attorney's Office for the District of Delaware; (f) the Department of

Justice; (g) the non-Debtor parties to the Rejected Contracts; and (h) all parties who have requested service of notices in these Chapter 11 Cases pursuant to Bankruptcy Rule 2002. The Debtors respectfully submit that this notice is sufficient under the circumstances.

No Previous Request

26. No previous request for the relief sought herein has been made by the Debtors to this or any other court.

WHEREFORE the Debtors respectfully request entry of the Proposed Order granting the relief requested herein and such other and further relief as the Court may deem just and proper.

**ORDER GRANTING DEBTORS’ SECOND OMNIBUS MOTION

Upon the motion (the “**Motion**”),² of Insys Therapeutics, Inc. and its affiliated debtors, as debtors and debtors in possession (collectively, the “**Debtors**”), for entry of an order (this “**Order**”), pursuant to sections 105(a) and 365(a) of title 11 of the United States Code (the “**Bankruptcy Code**”) and Rule 6006 of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”) authorizing and approving the rejection of the Rejected Contracts, effective as of October 11, 2019 (the “**Rejection Date**”); as more fully described in the Motion; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334, and the *Amended Standing Order of Reference from the United States District Court for the District of Delaware* dated February 29, 2012; and consideration of the Motion and the requested relief being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided, and it appearing that no other or further notice

need be provided; and the Court having reviewed the Motion; and the Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and it appearing that the relief requested in the Motion is in the best interests of the Debtors and their respective estates and creditors; and after due deliberation and sufficient cause appearing therefor:

IT IS HEREBY ORDERED THAT:

1. The Motion is granted to the extent set forth herein.
2. The Rejected Contracts, identified on **Exhibit 1** attached to this Order, are hereby rejected by the Debtors effective as of the Rejection Date.
3. Any claims arising from the rejection of the Rejected Contracts by the Debtors shall be filed by no later than thirty (30) days after the date of service of this Order in accordance with the procedures for filing proofs of claim set forth in the *Order Pursuant to 11 U.S.C. §§ 502(b)(9) and 105(a), Fed. R. Bankr. P. 2002, 3003(c)(3), 5005, and 9007, and Local Rules 2002-1(e), 3001-1, and 3003-1 for Authority to (I) Establish Deadlines for Filing Proofs of Claim, (II) Establish the Form and Manner of Notice Thereof, and (III) Approve Procedures for Providing Notice of Bar Date and Other Important Deadlines* [Docket No. 294].
4. Nothing herein shall prejudice the rights of the Debtors to argue that any of the Rejected Contracts were terminated prior to the Rejection Date or that any claim for damages arising from the rejection of the Rejected Contracts is limited to the remedies available under any applicable termination provision of such contract, as applicable, or that any such claim is an obligation of a third party and not that of the Debtors or their estates.
5. To the extent applicable, the requirements of Bankruptcy Rule 6006(f)(6) are hereby waived with respect to this Motion.

6. Adequate notice of, and an opportunity for a hearing on, the Motion has been provided, and such notice satisfies the requirements of Bankruptcy Rule 6004(a).

7. Notwithstanding any applicability of Bankruptcy Rules 6004(h), 7062, or 9014, the terms and conditions of this Order are immediately effective and enforceable upon its entry.

8. The Debtors are authorized and empowered to take all actions necessary to implement the relief granted in this order.

9. This Court shall retain jurisdiction to hear and determine all matters arising from or related to this Order.
