**DECLARATION AND DISCLOSURE STATEMENT OF JAMES H. NEALE,

JAMES H. NEALE, hereby declares, pursuant to 28 U.S.C. § 1746:

3. The Services include, but are not limited to, the following:

In addition, the Firm does not have any relationship with any such person, such person's attorneys, or such person's accountants that would be adverse to Republic or its estates with respect to the matters on which the Firm is to be retained.

5. Neither I, nor any principal of, or professional employed by the Firm has agreed to share or will share any portion of the compensation to be received from the Debtors with any other person other than principals and regular employees of the Firm.


