**ORDER GRANTING FIRST APPLICATION OF BELL NUNNALLY & MARTIN LLP
FOR ALLOWANCE OF INTERIM COMPENSATION FOR PROFESSIONAL
SERVICES RENDERED AND FOR REIMBURSEMENT OF EXPENSES INCURRED
AS SPECIAL COUNSEL FOR THE DEBTOR AND DEBTOR-IN-POSSESSION
FROM OCTOBER 6, 2015, THROUGH JANUARY 19, 2016**

The Court having considered the First Application of Bell Nunnally & Martin LLP (“BNM”) for Allowance of Interim Compensation for Professional Services Rendered and for Reimbursement of Expenses Incurred as Special Counsel for the Debtor and Debtor-in-Possession for the Period October 6, 2015, through January 19, 2016 (the “Application”) and it appearing to the Court that (a) the requested fees and expenses are reasonable and necessary; (b) that notice of the Application was sufficient and appropriate and in accordance with the Federal Rules of Bankruptcy Procedure and the Local Bankruptcy Rules of this District; (c) no objections or responsive pleadings having been filed; and (d) that good cause exists to grant the Application;

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED AS FOLLOWS:

1. The Application is hereby GRANTED and APPROVED on an interim basis in the amount of \$9,368.25, consisting of fees in the amount of \$9,363.50 and expenses in the amount of \$4.75, as an allowed administrative expense of the estate for the period October 6, 2015, through January 19, 2016.
2. Debtor is authorized and directed to pay BNM’s approved fees and expenses for

the Application Period.

3. Notwithstanding Bankruptcy Rule 6004, this order shall be immediately effective and enforceable upon its entry.

4. The Court shall retain jurisdiction to hear and determined all matters arising from or related to the implementation and enforcement of this Order.
