**ORDER GRANTING FIRST AND FINAL APPLICATION OF BRUNER-COX
LLP FOR COMPENSATION FOR SERVICES RENDERED AND
REIMBURSEMENT OF EXPENSES INCURRED AS ACCOUNTANTS FOR
DEBTORS**

This matter came before the Court pursuant to the *First and Final Application of Bruner-Cox LLP for Compensation for Services Rendered and Reimbursement of Expenses Incurred as Accountants for Debtors* (the "Application") [Docket No. 753]; the Court (a) having reviewed the Application and all the time entries related thereto; (b) having read the statements of Bruner-Cox LLP ("Bruner") regarding the relief requested in the Application; and (c) no responses or other objections to the Application or the

relief requested therein were filed; the Court finds that (i) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (ii) this is a core proceeding pursuant to 28. U.S.C. §157(b)(2), (iii) notice of the Application was just and proper, and (iv) the fees and expenses requested by Bruner pursuant to the Application were beneficial to the Debtors' estates and are reasonable and necessary expenses of the Debtors' estates. The Court concludes that the Application is well taken and HEREBY ORDERS THAT:

1. The Application is GRANTED as set forth herein.
2. Any terms not specifically defined herein shall have the same meaning as defined in the Application.
3. Bruner's fees for the Application Period in the amount of \$136,764.06 and Expenses in the amount of \$2,625.51 (the "Final Fees and Expenses") are hereby allowed on a final basis pursuant to 11 U.S.C. § 330. To the extent not already paid, the Debtors, the Debtors' estates and their successors, including to the extent applicable, the Creditor Trustee, are authorized and directed to pay any unpaid Final Fees and Expenses.
4. Bruner is authorized to apply the Prepetition Retainer to all unpaid Final Fees and Expenses awarded hereunder.
5. This Order is effective immediately.
